General Information

1. What action are you requesting from the Board?

Convene as the Governing Body of the Dunthorpe-Riverdale Sanitary Service District No. 1 and indorse the annexation petition.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The Dunthorpe-Riverdale County Service District (District) has received a petition by landowners for annexation of their property under ORS 198.857 to the District. The subject property is situated at the southern edge of the District and is split between Multnomah and Clackamas Counties. A copy of the signed petition is attached identified as Exhibit 1, and includes the legal description of the subject property.

Under ORS 198.857 (2), the petition must be approved by the District's Board by an indorsement thereon, before the petition is filed with the County Board. The Multnomah County Board of Commissioners serves as the board of the District since the largest portion of assessed value lies within Multnomah County.

The District staff finds that annexation of the subject property to the District is consistent with the goals and the Principal Act (ORS Chapter 451) and the petition meets the requirements of ORS 198.857, and therefore requests the District Board to indorse the annexation petition.

3. Explain the fiscal impact (current year and ongoing).

Indorsement of the petition has no fiscal impact on the District. Once the subject property is annexed into the District, the District will have the requisite authority to assess the necessary taxes, fees or charges against the property to meet the District's operational requirements.

4. Explain any legal and/or policy issues involved.

The Dunthorpe-Riverdale Service District is a County service district established under ORS 451 for sewer services for which the Multnomah County Board of County Commissioners serve as the Governing Board. See No. 2 above for further discussion.

EXHIBIT "ONE"

A portion of Block 132, DUNTHORPE, a recorded subdivision in Multnomah and Clackamas Counties, Oregon, described as follows:

Beginning at a point in the Northerly right of way line of Iron Mountain Boulevard, a 60 foot right-of-way, 15 feet Northwesternly of the Southeast corner of Block 132; thence Northwesternly, along the Northerly line of Iron Mountain Boulevard, a distance of 155 feet; thence North $50^{\circ}40'40''$ East 333 feet to a point on the Northerly line of Block 132 that is South $35^{\circ}08'$ East 135 feet from the Northwest corner thereof; thence along said Northerly line of Block 132, South $35^{\circ}08'$ East 100 feet; thence Southwesterly a distance of 334 feet to the place of beginning.
