

BEFORE THE BOARD OF COUNTY COMMISSIONERS FOR
MULTNOMAH COUNTY, OREGON
ORDINANCE NO. 176

An Ordinance amending Multnomah County Code, Section 5.10.320 and 5.10.340 relating to inspection fees for food service facilities and inspection fees for swimming pools, and adding a new section 5.10.345 relating to fees for inspection of recreational facilities and tourist and travelers' facilities, picnic parks and organizational camps.

Multnomah County ordains as follows:

- 1) Multnomah County Code 5.10.320 is amended as follows:

Food Service Inspection Fee

For the service of the Department of Human Services in connection with issuance of food service licenses, the Department shall collect from every applicant, at the time of application, \$50 [\$25] for each temporary food license issued or applied for, \$100 [\$60] for each regular food license issued or applied for, and \$50 [\$25] for each limited service food license issued or applied for.

For licenses issued or applied for for the following special food service facilities the following fees shall be charged:

2) Multnomah County Code 5.10.340 is amended to read as follows:

Swimming Pool Inspection Fee. For the services of the Department of Human Services in connection with swimming pool inspections the department shall collect a \$75 (\$50) annual license fee.

3) New Section 5.10.345 is added as follows:

Tourist and Travelers Facilities Inspection Fee.

For the services of the Department of Human Services in connection with issuance of licenses the Department shall collect from every applicant, at the time of application, the following fees:

a) Tourist and Travelers Facilities

1 -	25 units	\$50
26 -	50 units	\$75
51 -	75 units	\$100
76 -	100 units	\$125
101 and over		\$125 plus \$1 per unit over 101 units

b) Recreational Parks \$30


c) Picnic Parks \$30

d) Organizational Camps \$30
