RESOLUTION NO. 00-007

Authorizing the Execution of Deed D001702 Upon Complete Performance of a Contract with Betty L. Remme

The Multnomah County Board of Commissioners Finds:

- a) On 9/30/91, Multnomah County entered into a county contract 15617 recorded in county deed records at Book 2464 Page 2675 with BETTY L. REMME for the sale of the real property hereinafter described
- b) That Betty L. Remme, was the former owner and is now deceased.
- c) Oregon Title Company has requested deed to be made out to "Deborah K. Funk as Personal Representative of the Estate of Betty L. Remme, Deceased, Case No 990891476, Circuit Court for Multnomah County, Oregon" as grantee
- d) The terms and conditions of said contract have been fully completed and the grantee is now entitled to a deed conveying said property to said purchaser; now therefore

The Multnomah County Board of Commissioners Resolves:

- 1. That the Chair of the Multnomah County Board of County Commissioners is authorized to execute a deed in a form substantially complying with the attached deed conveying to the contract purchaser the following described real property:

- 2. The County's Division of Assessment and Taxation is authorized to forward the signed deed to the appropriate Escrow Officer under letter of instruction which shall provide: (a) that the deed is to be processed only upon the receipt by the County of all funds the County is due in consideration for the above described property, and (b) that if the escrow is closed without the proper payment to the County the deed and any copies there of shall be returned immediately to the County.
