Beginning at a 5/8 inch diameter iron rod at the northwest corner of the said Lot 2; Thence North  $89^{\circ}37'40''$  West along the north line of the said "GLENN VILLE" and the south line of the said Lot 3 a distance of 105.17 feet to a 5/8 inch diameter iron rod at the southwest corner of said Lot 3; Thence North  $00^{\circ}13'10''$  West along the west line of the said Lot 3 a distance of 75.39 feet; Thence South  $89^{\circ}37'40''$  East, parallel to the south line of the said Lot 3 a distance of 299.15 feet to the west line of S.E. 130th Avenue, 30.00 feet west of the center line thereof; Thence South  $00^{\circ}13'10''$  East, along said last said west line, a distance off 75.39 feet to the northwest corner of said Lot 2 and to a 5/8 inch diameter iron rod inside a 2" galvanized pipe; Thence North  $89^{\circ}37'40''$  West along the north line of said Lot 2 a distance of 138.00 feet to a 5/8 inch diameter iron rod; Thence South  $52^{\circ}33'42''$  West a distance of 11.49 feet to a 5/8 inch diameter iron rod; Thence North  $89^{\circ}37'40''$  West a distance of 46.83 feet to a 5/8 inch diameter iron rod on the west line of said Lot 2; Thence North  $00^{\circ}13'10''$  West along the west line of said Lot 2 a distance of 7.04 feet to the above referenced point of Beginning.

A tract of land in the southwest one-quarter of Section 2, Township 1 South, Range 2 East, Willamette Meridian, Multnomah County, Oregon, said tract of land being a part of Lot 2, Block 1, "GLENN VILLE", a plat duly recorded August 2, 1990 in Book 1221, Pages 70 and 71, Multnomah County Plat Records, said tract of land being more particularly described as follows:

Beginning at a 5/8 inch diameter iron rod at a point in the west line of said Lot 2, said iron rod bearing south  $00^{\circ} 13' 10''$  east a distance of 7.04 feet from the northwest corner of said Lot 2; thence south  $89^{\circ} 37' 40''$  east, parallel with the north line of said Lot 2, a distance of 46.83 feet to a 5/8 inch diameter iron rod; thence north  $52^{\circ} 33' 42''$  east a distance of 11.49 feet to a 5/8 inch diameter iron rod in the north line of said Lot 2; thence south  $89^{\circ} 37' 40''$  east, along the north line of said Lot 2, a distance of 138.00 feet to the northeast corner thereof; thence south  $00^{\circ} 13' 10''$  east, along the east line of said Lot 2, a distance of 16.00 feet to a 5/8 inch diameter iron rod marking the northeast corner of Lot 1, Block 1, "GLENN VILLE"; thence north  $89^{\circ} 37' 40''$  west, along the north line of said Lot 1, a distance of 95.38 feet to a 5/8 inch diameter iron rod marking the northwest corner thereof; thence south  $00^{\circ} 13' 10''$  east, along the west line of said Lot 1 and the east line of said Lot 2, a distance of 59.39 feet to a 5/8 inch diameter iron rod marking the southeast corner of said Lot 2; thence north  $89^{\circ} 37' 40''$  west, along the south line of said Lot 2, a distance of 98.60 feet to a 5/8 inch diameter iron rod marking the southwest corner of said Lot 2; thence north  $00^{\circ} 13' 10''$  west, along the west line of said Lot 2, a distance of 68.35 feet to the point of beginning.
