Setting The Public Hearing Date Of January 12, 2012 For The Proposed Transfer Of A Tax Foreclosed Property To A Non Profit, Oregon Sustainable Agriculture Land Trust (OSALT) For Perpetual Public Use And Directing Publication Of The Public Notice

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, the following described real property located in Multnomah County, Oregon:

Tract "A", Tessa Court

Hereinafter referred to as "the Property". The Tax Account Number for the Property is: R487336

- b. ORS 271.330 and Multnomah County Code (MCC) Chapter 7 allow for the transfer of real property to a nonprofit corporation for the creation of open space, parks or natural areas for perpetual public use. The County received a request from OSALT for transfer of the Property for a proposed conversion to a community garden.

**The Multnomah County Board of Commissioners Resolves:**

1. Pursuant to MCC 7.410 (A) the OSALT request for transfer of the Property for the creation of open space, parks or natural areas for perpetual public use is set for hearing before this board on January 12, 2012 at 9:30 a.m.
2. As required under MCC 7.410(B); the Multnomah County Office of Sustainability is directed to publish notice of the public hearing as provided in the attached "Notice of Public Hearing" identified as Exhibit A to this resolution.
