A parcel of land situated in the northeast one-quarter of Section 34, T1N, R4E, W.M., Multnomah County, Oregon, being described as follows:

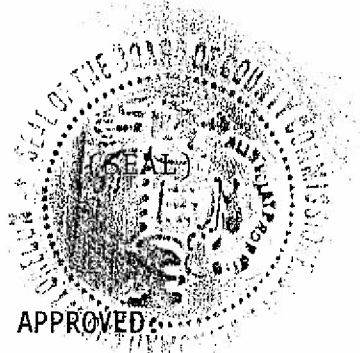
