





Primary Election Highlights

Voter Registration - About 460,000 as of 5/17

- Phone Bank - Almost 10,000 calls from 4/21 - 5/17
- In Person Voters - 1,674 in lobby on 5/16 and 5/17
- Order Ahead Replacement Ballots - 721 total
- Reduced Labor for Opening Boards
- Write-in Adjudication Tool
- Ballot Tracking - 10,758 or 2% of registered voters used it



Presidential General Planning

Largest turnout in 4-year cycle

- 2008 - 86% of 426,567 registered
- 2012 - 82% of 446,304 registered
- 2016 - ??% of 500,000 registered (projection)



Presidential General Planning

Focus on improving the experience of the voter

- Active media presence and outreach to communicate deadlines
- Reduce lines through expanded service hours
- Reduce lines through order ahead replacement ballots
- Increase transparency through ballot tracking
- Dedicated parking for voters
- Security of the election process


Research Objectives

- Explore most effective ways to communicate with voters.




Confidence that ballots are counted accurately

Countywide Survey Response




Knowledge of the Voting Process

Countywide Survey Response




Reasons that kept people from voting







Percent Change in Registered Voters




Percent Change in Registered Voters



Downtown and into North Portland


East Portland, Rockwood, Gresham and Wood Village
