**RESOLUTION NO. 2014-023**

Authorizing the Private Sale of a Tax Foreclosed Property to University of Portland.

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A (the "Property").
- b. ORS 275.225 allows the County to sell County owned property, including property acquired through tax foreclosure, at a private sale if that property meets certain conditions with respect to value and the applicable zoning and building codes.
- c. The Property has a real market value of \$210 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1)(a).
- d. Although no written confirmation from the City of Portland was obtained, the County is confident that the location and size of the Property make it unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1)(b).
- e. The County has received payment in the amount of \$250 from University of Portland, an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.

**The Multnomah County Board of Commissioners Resolves:**

1. The County Chair is authorized to execute a deed, in substantial conformance with the deed attached as Exhibit A, conveying the Property to University of Portland, in consideration of \$250.



**Legal Description:**

A PARCEL OF LAND LOCATED IN THE NORTHWEST ONE-QUARTER OF SECTION 18, TOWNSHIP 1 NORTH, RANGE 1 EAST OF THE WILLAMETTE MERIDIAN AND BEING A PORTION OF THE SOUTH ONE-THIRD OF LOT 16, BLOCK 36, OF THE PLAT OF "PORTSMOUTH" RECORDED IN BOOK 151, PAGE 86, MULTNOMAH COUNTY PLAT RECORDS, ALSO BEING A PORTION OF THE NORTHERLY HALF OF VACATED FRONT STREET EXTENDING 30 FEET MORE OR LESS, SOUTH OF THE SOUTH LINE OF SAID LOT 16 AND 14 FEET MORE OR LESS, WEST OF THE EAST LINE OF SAID LOT 16.
