**RESOLUTION NO. 04-010**

Filling a Vacancy in the Legislative Assembly, Oregon State Representative District 35

**The Multnomah County Board of Commissioners Finds:**

- a. Effective December 31, 2003, there is a vacancy in Oregon State Representative, District 35 due to the resignation of State Representative Max Williams.
- b. Pursuant to state law, on Thursday, January 15, 2004, the Republican Party Precinct Committeepersons in Oregon State Representative District 35 made nominations to fill the vacancy.
- c. The nominees chosen were: David Crowe, Dimitri Fernando Guillen and Philip R. Yount.
- d. In accordance with procedures established by the Secretary of State, the Washington County Board of Commissioners and the Multnomah County Board of Commissioners considered the nominations at a joint public meeting on Wednesday, January 28, 2004.
- e. In accordance with ORS 171.062 each County is entitled to one vote for each 1,000 registered electors or major fraction of 1,000 (more than 500 registered electors, but less than 1,000) within Oregon State Representative 35; and each County Commissioner is allotted the following number of votes:  
Multnomah County: 2,267 or 2 votes divided by 5 = .4 votes per Commissioner  
Washington County: 28,899 or 29 votes divided by 5 = 5.8 votes per Commissioner
- f. At the conclusion of the public meeting the Commissioners voted to appoint **Philip R. Yount** to fill the vacancy, said nominee having received the highest number of votes as indicated on the vote tabulation attached as **Exhibit A**.

**The Multnomah County Board of Commissioners Resolves:**

1. **Philip R. Yount** is selected as the appointee to fill the vacancy in the Legislative Assembly, Oregon State Representative District 35.
2. This Resolution shall promptly be forwarded to the Secretary of State as required by ORS 171.060(3).


