

DCHS FY09 Budget by divisions


Total Budget \$187,678,406

Total Budget \$187,678,406



FY09 Adopted Budget



What we know about the populations we serve*

❖ *Diversity*

- **Among people at least five years old living in Multnomah County in 2007, 19 percent spoke a language other than English at home. Of those, 47 percent spoke Spanish and 53 percent spoke some other language**

❖ *Poverty*

- **45 percent of homeowners in the county are 'rent burdened', up from 39 percent in 2002.**
- **Multnomah County poverty rate for seniors is 37 percent higher than the state rate**
- **64 percent of adults with disabilities are living in poverty**
- **On any given night, 1,090 children find themselves homeless in Multnomah County. Of these, 498 children are under the age of five****

❖ *Unmet need*

- **The average length of stay at an emergency Domestic Violence shelter has increased from 21 days in 2001 to 56 days in 2008, in large part because of the lack of affordable housing**
- **More than 500 adults are on a waitlist for addiction residential services**






