The department is requesting board approval of budget modification DCA-01 reclassifying a Data Analyst to a Finance Specialist Senior.

This modification reflects a Class/Comp decision on a classification request initiated by management. This is a new position in a new unit providing complex accounting and contract oversight for the Multco Marketplace, the county-wide system for procuring goods. Class/Comp reviewed the submitted job duties and description and concluded that Finance Specialist Senior was the best fit for the position. This change impacts program offer 78046 County Wide Strategic Sourcing.

Personnel costs increase by \$12,768 and temporary personnel cost decrease by a like amount. On going personnel cost will be covered with existing program resources. Service reimbursement to the risk fund increases by \$457.
