R-1 RESOLUTION Adopting the 2003-04 Budget for Multnomah County and Making Appropriations Thereunder, Pursuant to ORS 294.435

COMMISSIONER CRUZ MOVED AND COMMISSIONER ROJO SECONDED, APPROVAL OF R-1. KARYNE DARGAN EXPLANATION OF VARIOUS AMENDMENTS DISCUSSED DURING BUDGET WORK SESSIONS AS SET FORTH ON COLOR CODED DOCUMENTS PROVIDED TO THE BOARD AND AUDIENCE, AND REQUEST FOR BOARD ACTION AS FOLLOWS:

UPON MOTION OF COMMISSIONER ROBERTS, SECONDED BY COMMISSIONER CRUZ, THE TECHNICAL AMENDMENTS WERE UNANIMOUSLY APPROVED.

UPON MOTION OF COMMISSIONER ROBERTS, SECONDED BY COMMISSIONER CRUZ, THE REVENUE AMENDMENTS WERE UNANIMOUSLY APPROVED.

UPON MOTION OF COMMISSIONER ROJO, SECONDED BY COMMISSIONER NAITO, THE STAFF AMENDMENTS WERE UNANIMOUSLY APPROVED.

UPON MOTION OF COMMISSIONER ROBERTS, SECONDED BY COMMISSIONER CRUZ, THE CARRYOVER AMENDMENTS WERE UNANIMOUSLY APPROVED.

UPON MOTION OF COMMISSIONER ROBERTS, SECONDED BY COMMISSIONER ROJO, THE PROGRAM AMENDMENTS WERE UNANIMOUSLY APPROVED.

COMMISSIONER NAITO MOVED, SECONDED BY COMMISSIONER ROJO, APPROVAL OF THE BOARD AMENDMENTS. FOLLOWING DISCUSSION, COMMISSIONER ROJO MOVED, SECONDED BY COMMISSIONER CRUZ, TO WITHDRAW BOARD AMENDMENT 04 NOND BA 02 (PROPOSED REDUCTION OF APPROPRIATION TO THE PORTLAND-MULTNOMAH PROGRESS BOARD). WITHDRAWAL OF BOARD AMENDMENT 04 NOND BA 02 WAS UNANIMOUSLY APPROVED. COMMISSIONER CRUZ EXPLANATION OF BOARD AMENDMENT 04 HD BA 03 (RESTORATION OF HIV PREVENTION PROGRAM IN HEALTH DEPARTMENT) IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS. COMMISSIONER NAITO ADVISED THE LIST OF BOARD AMENDMENTS INCLUDE AN ADDITIONAL \$100,000 FOR THE HOMELESS YOUTH SYSTEM. THE BOARD AMENDMENTS WERE UNANIMOUSLY APPROVED, AS AMENDED.

FOLLOWING EXPLANATION OF KARYNE DARGAN AND UPON MOTION OF COMMISSIONER NAITO, SECONDED BY COMMISSIONER CRUZ, THE AMENDED APPROPRIATIONS WERE UNANIMOUSLY APPROVED.

FOLLOWING EXPLANATION OF KARYNE DARGAN AND UPON MOTION OF COMMISSIONER CRUZ, SECONDED BY COMMISSIONER ROBERTS, THE COUNTY'S RESPONSE TO THE TAX SUPERVISING AND CONSERVATION COMMISSION WAS UNANIMOUSLY APPROVED.

FOLLOWING EXPLANATION OF KARYNE DARGAN, COMMISSIONER NAITO MOVED AND COMMISSIONER ROJO SECONDED, AN AMENDMENT TO THE THIRD SENTENCE OF THE GATEWAY CHILDREN'S CENTER BUDGET NOTE, TO READ: "THE BOARD WISHES TO FUND SERVICES THROUGH SEPTEMBER 30, 2003 AND RECOGNIZES RENTAL PAYMENTS FROM THE CAMPUS IN EXCESS OF ACTUAL FACILITY EXPENSES MAY BE NEEDED BEYOND THAT DATE TO FILL OPERATING SHORTFALLS IF FUNDING IS NOT GRANTED UNDER THE CHILDREN'S LEVY." COMMISSIONER NAITO EXPLANATION AND COMMENTS IN SUPPORT. AMENDMENT TO GATEWAY CHILDREN'S CENTER BUDGET NOTE

UNANIMOUSLY APPROVED. CHAIR LINN COMMENTED IN SUPPORT OF THE BOARD AMENDMENT PROVIDING AN ADDITIONAL \$100,000 TO THE HOMELESS YOUTH SYSTEM AND THE BUDGET NOTE STATING THAT THE BOARD WILL REVIEW THE HOMELESS YOUTH SYSTEM IN JULY AND ALLOCATE APPROPRIATE AVAILABLE FUNDS FROM OTHER SOURCES, ITAX OR CONTINGENCY. FOLLOWING EXPLANATION BY KATHY TURNER AND UPON MOTION OF COMMISSIONER NAITO, SECONDED BY COMMISSIONER CRUZ, THE COLA SAVINGS FROM NON-REPRESENTED EMPLOYEES BUDGET NOTE WAS DELETED, WITH COMMISSIONERS NAITO, CRUZ, ROJO AND LINN VOTING AYE, AND COMMISSIONER ROBERTS VOTING NO. UPON MOTION OF COMMISSIONER NAITO, SECONDED BY COMMISSIONER CRUZ, THE BUDGET NOTES WERE UNANIMOUSLY APPROVED, AS AMENDED.

BRUCE MINEAU, ROBERT TSHOW AND RANDALL SORVISTO TESTIMONY IN SUPPORT OF A RECOVERY ASSOCIATION PROJECT PROPOSED METHADONE DETOX DEMONSTRATION PROJECT WITH HOOPER CENTER AND METHADONE PROVIDERS. JOSHUA BICKLE AND ZAC HALL TESTIMONY IN SUPPORT OF FUNDING FOR THE HOMELESS YOUTH CONTINUUM. CHAIR LINN ASKED THAT THOSE SPEAKERS ON BEHALF OF FUNDING FOR HELEN'S VIEW RISE AND HOMELESS YOUTH CONTINUUM CONTACT HER STAFF ASSISTANT ANDY SMITH FOR FURTHER INFORMATION REGARDING COUNTY BUDGET ALLOCATIONS FOR THOSE PROGRAMS.
