### General Information:

#### 1. What are you requesting from the Board?

Appointment of the following individual to the Community Involvement Committee:

**Jean Trygstad, District 1.** This 2nd term appointment will begin February 8, 2018 and end February 8, 2021. Trygstad previously served one term on the CIC beginning February 12, 2015.

#### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer(s) this action affects and how it impacts the results.

Multnomah County's Office of Citizen (now Community) Involvement ("OCI") facilitates communication between the people of Multnomah County and the Board of County Commissioners. The structure of the Community Involvement Committee ("CIC") is established by County Code Chapter 3. Community groups and neighborhood associations in Multnomah County nominate CIC members for appointment to 3-year terms by the Board of County Commissioners. In accordance with County Code 3.251, the CIC shall be composed of 15 members, with three nominated from each of the four County Districts and three nominated at large. CIC members have a 2 consecutive term limit.

This nomination meets the eligibility criteria set forth by Chapter 3 of the County Code.

**3. Explain the fiscal impact (current year and ongoing).**

**4. Explain any legal and/or policy issues involved.**

This nomination process is consistent with the County Charter and Code.

**5. Explain any citizen and/or other government participation that has or will take place.**

The OCI actively and continually recruits new members for CIC, CBAC, and Audit Committee appointments with local community media; outreach to East County cities and communities; Sauvie Island/Corbett Springdale residents; community groups, faith-based communities, multicultural agencies, organizations and events; social media such as facebook and list-serves; and word of mouth through community meetings and events.
