Vice-Chair Lonnie Roberts convened the meeting at 6:03 p.m., with Commissioners Serena Cruz Walsh and Maria Rojo de Steffey present, Commissioner Lisa Naito arriving at 6:12 p.m., and Chair Diane Linn excused.
