TESTIMONY OF BARBARA SPEARS AUGUST 16, 2018

Multnomah County Animal Services is failing to fulfill its mission to protect the health, safety and welfare of people and pets throughout Multnomah County.

County auditors know it.

County animal lovers and taxpayers know it.

Most MCAS shelter staff and volunteers know it.

The only ones who don't seem to know it are the people on this commission.

Auditors' reports from 2002, 2008, two from 2016 and the latest from July 2018, show the same exact pattern of failure has plagued the agency for decades.

In addition to years past, we now know that the must touted live release rate numbers cannot be trusted.

Your excuses for not stepping up to fix it are the same ones used by all those who have gone before you:

First - deny the problem. The auditor is exaggerating.

Second - support band-aid measures that make it appear that problems are being addressed.

Third - state that there's not enough money and staff. Are you aware that in ten years, MCAS intake has decreased 51% while its budget has increased 81% and the number of full time staff has almost doubled?

Just think, if you delay addressing the failure head-on long enough, when the next auditor's report comes out exposing the same failures or worse, in say, 2025 or 2030, it will be someone else's problem.

Jon and I have no other motivation to fight for change other than our love for animals and the knowledge that Multnomah County can have an efficient, humane, high performing shelter when one of you decides to make it happen.

Until then, we will not shut up and we will not go away.
