General Information

1. What action are you requesting from the Board?

Authorization for the Director of the Health Department to submit an application to Boehringer Ingelheim Pharmaceuticals, Inc. for up to \$15,000 to pilot training using clinical simulation.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Boehringer Ingelheim Pharmaceuticals, Inc. provides Medical Education Grant support for specific independent educational activities for healthcare providers and patients that may translate to better management of disease and improvement in patient safety and population health. An independent educational program may be at the national, regional or local level and may include, but is not limited to, live and interactive didactic presentations (e.g., symposia at major educational meetings, grand rounds, regional workshops), web-based programs, print and electronic monographs and other innovative educational formats.

MCHD proposes the development and implementation of a diabetes-focused training for nurses and support staff using simulation methodology. Simulation is used to imitate clinical scenarios that force participants to develop and enhance skills in assessment, critical thinking, problem solving and analysis. As we move to Alternative Payment Models, where providers are paid a per member/per month sum to care for patients, it is critical that nurses, medical assistants, and other professionals are well trained in the most current approaches and therapeutic modalities to provide the best, most cost effective care that leads to the best health outcomes. This training is especially important in the area of diabetes, as the percentage of diabetic patients who have their diabetes under control is a performance measure for MCHD Community Health Centers, and diabetes has been named a training priority for MCHD's healthcare workforce. Diabetes is also one of the 11 therapeutic subject areas for which Boehringer Ingelheim is interested in providing funding. Simulation training is the perfect medium for these training needs since it provides an opportunity to practice skills, such as patient education, that cannot be honed in classroom or didactic approaches to learning.

3. Explain the fiscal impact (current year and ongoing).

This grant would provide the Health Department with up to \$15,000 over approximately a one year period to pilot the training.

The granting agency is Boehringer Ingelheim Pharmaceuticals, Inc.

The training curriculum and simulation lab will be developed by the end of the funding period, so no further funding will be required.
