General Information:

1. What action are you requesting from the Board?

- The Multnomah County Sheriff's Office (MCSCO) is respectfully requesting the Board of Commissioners approve the Interstate Mutual Law Enforcement Assistance Agreement, which provides reciprocal, cross jurisdictional authority to legally perform duties necessary to protect life and property and investigate crimes.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer(s) this action affects and how it impacts the results.

- In support of intergovernmental collaboration, provisions within Oregon and Washington law allow for mutual aid among law enforcement entities. MCSCO and the Clark County Sheriff's Office (CCSO) further recognize their geographical proximity and the migration of criminal activity, therefore desire to communicate and coordinate operationally over criminal incidents; a pursuit from one state to another and the corresponding investigation is but one example.

- As a result, this Agreement directs members in each agency to provide notice of their presence in the other's respective jurisdiction and to report on any official activity that has been taken (e.g. arrest, search, seizure, etc.) under the commissioned authority granted herein.
- With Board approval, MCSO and CCSO would further agree to provide aid or assistance in the form of personnel, equipment and/or supplies to all extents possible when events occur that exceed the operational capacity of either Agency; a natural disaster, such as wildfire, is but one example.
- The term of this Agreement is five (5) years.
