WHEREAS, Robert E. Smalley has tendered to MULTNOMAH COUNTY a deed for public road purposes; and

WHEREAS, MULTNOMAH COUNTY does not desire the property for a county road, but the premises are suitable as a public road as defined in ORS Ch. 368, based on the recommendation of the Director of the Department of Environmental Services that the property be accepted as a public road and not as a county road;

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The deed of Robert E. Smalley to MULTNOMAH COUNTY is accepted for use as a public road, but not accepted for use as a county road at this time.

2. The real property conveyed to MULTNOMAH COUNTY and accepted by this Order is described as follows:

A parcel of land situated in the southeast one-quarter of Section 11, T1S, R2E, W.M., Multnomah County, Oregon, being the north 25.00 feet of that tract of land conveyed to Robert E. Smalley by deed, recorded May 7, 1981, in Book 1522, Page 587, deed records of Multnomah County, Oregon, which is described as follows:

A tract of land in Section 11, T1S, R2E, W.M., in the County of Multnomah and State of Oregon, described as the north 160 feet of the following described real property, to wit:

Commencing at the northeast corner of a 20 acre tract conveyed to Peter G. Carlson by deed recorded in Book 675, Page 66, Deed Records; running thence west 264 feet to the place of beginning of property to be described; thence west 165 feet; thence south 330 feet; thence east 165 feet; thence north 330 feet to the point of beginning.

Containing 4,125 square feet, more or less.




