General Information

1. What action are you requesting from the Board?

The Multnomah County Board of Commissioners have previously been briefed on the results of the 2014 Synar study, which found that 31% of Multnomah County tobacco retailers unlawfully selling tobacco to minors. Nicotine, a primary ingredient in cigarettes and most e-cigarettes, is highly addictive and is known to interfere with adolescent brain development. The Multnomah County Board of Health passed a policy to regulate retail sales and use of inhalant delivery systems to youth in the County. This briefing will explore price sensitivity of youth and e-cigarette taxation systems that could potentially further deter youth e-cigarette access and use.

The Multnomah County Commission and Multnomah County Board of Health have held briefings and sought public testimony on e-cigarettes and youth access in numerous venues over the past 6 months. Multnomah County Health Department officials have presented before the City Councils in Troutdale, Fairview, and Portland. The Oregon State

Legislature had a set of e-cigarette and tobacco bills filed in this 2015 legislative session, and has held several hearings on youth access, e-cigarette regulation, licensure, flavoring, and other related issues.
