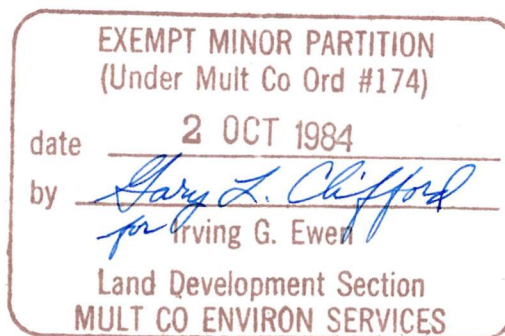
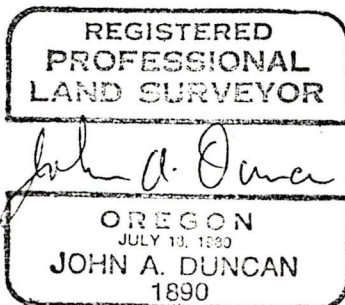

Beginning at the North Quarter corner of said Section 36, thence South $0^{\circ}29'39''$ West along the North, South centerline of said Section 36, a distance of 705.00 feet; thence North $89^{\circ}59'42''$ East, parallel with the North line of said Section 36, a distance of 1163.71 feet to the West right-of-way line of Rocky Point Road; thence following said West right-of-way the following courses and distances, North $3^{\circ}06'13''$ East 498.40 feet, South $80^{\circ}53'52''$ West 1.89 feet, and North $9^{\circ}06'08''$ West 210.26 feet to the North line of said Section 36; thence South $89^{\circ}59'42''$ West, along said section line, a distance of 1149.42 feet to the place of beginning.

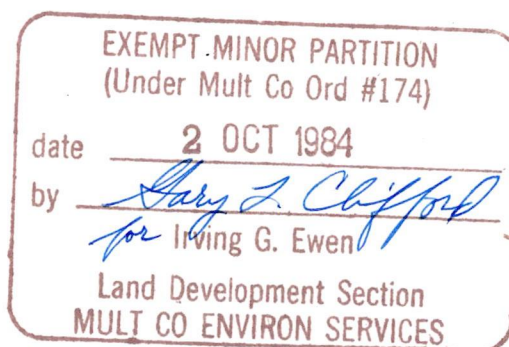
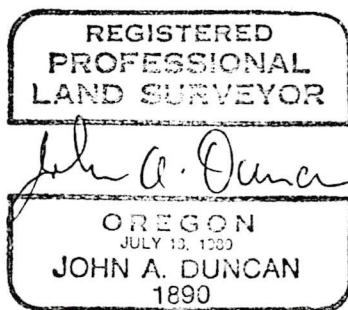

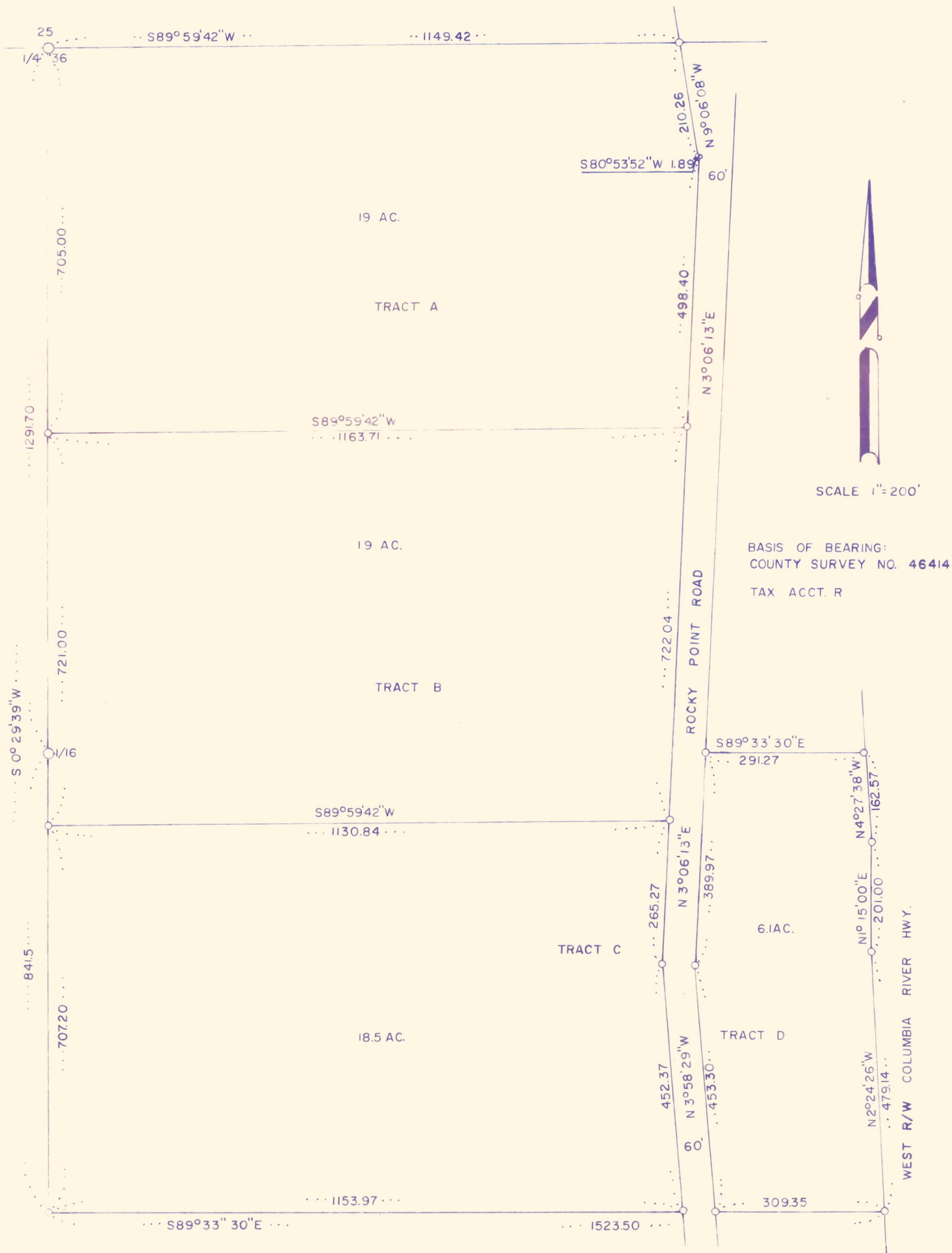
