SECTION I. Multnomah County Code Section 5.10.420 is amended  
 as follows:

5.10.420 Fees for services of [Division of Public  
 Safety] Multnomah County Sheriff's Office. The  
 [Division of Public Safety] Multnomah County Sheriff's  
 Office shall collect the following fees for providing  
 the following documents or services:


