Handout: FY 12 Multnomah County Budget Index
General fund gap to maintain current service level: \$5.3 mil or 1.5%
Amount of one-time-only funding after fully funding contingency & reserves: \$13 mil
County-wide management salary freeze savings: \$1.5 mil
2% constraint = \$6.4 million on going
Jeff will meet with Department Directors in January, 2011
Date Program Offers are due: February 18, 2011
Number of public budget forums prior to executive budget release: two
Projected State Budget Shortfall: \$3.5 billion or 22% of State General Fund
Percentage of Multnomah County's overall budget funded by the State: 25-30%

Jeff is looking to the departments to propose cuts for a total of \$4 mil or more
Coraggio recommends budget for outcomes; change process to do so
Shprack: concern about spending it "all" and like to see them cut their budgets 2%
without cutting services
McK: biggest cuts which depts.?
Cogen: depends on decisions @ legislature
Probably DCHS and DCJ see largest cuts
