

BEFORE THE BOARD OF COUNTY COMMISSIONERS FOR

(Levying Ad Valorem Property)
 (Taxes for Multnomah County,) RESOLUTION 97-121
 (Oregon for Fiscal Year 1997-98)

WHEREAS on May 12, 1997, the Board of County Commissioners approved the budget for Multnomah County, Oregon, for the fiscal year beginning July 1, 1997 and ending June 30, 1998, to the Tax Supervising and Conservation Commission; and

WHEREAS on June 5, 1997, the Tax Supervising and Conservation Commission met and discussed the budget,; and

WHEREAS on June 19, 1997 the Board of County Commissioners adopted the budget for Multnomah County, Oregon for the 1997-98 fiscal year, and that budget provides for ad valorem property taxes levied on all property in Multnomah County; now therefore

IT IS RESOLVED that the Board of County Commissioners of Multnomah County hereby levies the taxes provided for in the adopted budget in the aggregate amount of \$183,026,126 and that these taxes are levied upon all taxable property within Multnomah County. The following allocation and categorization subject to the limits of section 11b, Article XI of the Oregon Constitution make up the aggregate levy:

IT IS FURTHER RESOLVED that the amounts levied as specified above upon all taxable property in Multnomah County are subject to review and revision by the Division of Assessment and Taxation of the actual assessed value of taxable property in Multnomah County and may, depending on that value and other circumstances, be reduced before the tax bills for Multnomah County are prepared by the Division of Assessment and Taxation.


Town Center storefront for animals not adopted at regional Animal Control Centers.


