CHIEF OF STAFF CHRISTINE KIRK EXPLANATION.

COMMISSIONER COGEN MOVED AND COMMISSIONER ROJO SECONDED, APPROVAL OF AMENDMENT APPROPRIATING \$130,000 GENERAL FUND CONTINGENCY TO OPERATE 57 JAIL BEDS AT THE DETENTION CENTER UNTIL THE END OF THE MONTH.

COMMISSIONERS ROBERTS AND COGEN VOICED THEIR CONCERNS. COMMISSIONER NAITO SUGGESTED THAT BECAUSE OF CHANGES IN THE BUDGET PROCESS, A GROUP BE FORMED TO REVIEW AND REPORT HOW ALL

THE PROGRAMS ARE WORKING SO THE BOARD CAN THEN MAKE A DECISION. MS. KIRK AND CAPTAIN BOBBI LUNA RESPONSE TO BOARD QUESTIONS AND DISCUSSION ON ISSUES INCLUDING USE OF JAIL BEDS; FUNDING FOR CORRECTIONS HEALTH BEDS; OFFENDER POPULATION AND FIELD BASED WORK RELEASE, AND WHETHER THE DEPARTMENT CAN OPERATE JAIL BEDS ON A MONTHLY BASIS PENDING REVIEW AND ANALYSIS FOR FUTURE BOARD POLICY DETERMINATION.

FOLLOWING DISCUSSION REGARDING THE INCLUSION OF CORRECTIONS HEALTH AND THE CORRECT AMOUNT OF MONTHLY FUNDING AND UPON MOTION OF COMMISSIONER COGEN, SECONDED BY COMMISSIONER ROJO, AMENDMENT APPROPRIATING \$167,000 GENERAL FUND CONTINGENCY [FOR SHERIFF'S OFFICE AND CORRECTIONS HEALTH] TO CONTINUE TO OPERATE 57 JAIL BEDS AT THE MULTNOMAH COUNTY DETENTION CENTER FOR ONE MONTH.
