General Information:

1. What action are you requesting from the Board?

- The Multnomah County Sheriff's Office (MCSO) respectfully requests the Board of Commissioners approve Intergovernmental Agreement 250-1819, which authorizes MCSO to conduct enforcement related to recreational boating via its River Patrol Unit and the Oregon State Marine Board (OSMB) to contribute funding towards this service.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer(s) this action affects and how it impacts the results.

- Intergovernmental Agreement 250-1819, relates to Program Offer 60515-19, River Patrol. The Agreement authorizes MCSO to conduct enforcement related to recreational boating via its River Patrol Unit and the OSMB to contribute some of the funding needed to support the River Patrol Unit and its functions (e.g. staffing, fuel, supplies, maintenance, etc.).

- MCSO's River Patrol Unit partners with the OSMB to implement a Statement of Work and Annual Action Plan, as outlined in Intergovernmental Agreement 250-1819. Together these provisions provide for the safe commercial and recreational access and passage to the County's 110 miles of waterways along the Columbia River, Willamette River, Sandy River and Multnomah Channel. More specific highlights of these provisions include, but are not limited to, the: 1) inspection of boats and enforcement of applicable regulations, 2) the investigation of complaints over boating violations and/or accidents, 3) issuance of communications about unsafe boating conditions and providing assistance/search and rescue missions for boaters in need, and 4) the development and execution of interventions to address boater behaviors that have potential to cause accidents, injuries and/or fatalities (e.g. BUII, speeding, operator inattention, derelict boats, etc.).
- MCSO's River Patrol Unit is key to emergency preparedness on and near regional waterways; members participate in numerous intergovernmental collaborations and are a significant function to a visible public safety system.

3. Explain the fiscal impact (current year and ongoing).

- Per Intergovernmental Agreement 250-1819, OSMB will pay MCSO an amount not to exceed \$795,107, for enforcement services in FY 2019. This revenue has been anticipated and is included in the FY 2019 adopted budget. MCSO and OSMB will communicate monthly about law enforcement efforts and will provide for service reimbursements on a quarterly basis.

- Intergovernmental Agreement 250-1819 has been reviewed by the County Attorney's Office.
