JOHN LINDENTHAL EXPLANATION AND RESPONSE TO CHAIR WHEELER AND VICE-CHAIR SHIPRACK QUESTIONS AND COMMENTS REGARDING WHETHER A MOISTURE BARRIER WAS PUT IN, THE NEED FOR DOING PROJECTS TO SPECIFICATIONS, THIRD PARTY INSPECTIONS AND THE NEED FOR COUNTY OWNERS TO BE MORE VIGILENT.

REALLOCATION UNANIMOUSLY APPROVED. [5-0]

R-3 BUDGET MODIFICATION DCJ-04 Reducing One Full-Time AFSCME Local-88 Position and Restoring the Services through an Intergovernmental Agreement with Multnomah Education Service District

COMMISSIONER COGEN MOVED AND COMMISSIONER KAFOURY SECONDED, APPROVAL OF R-3.

ROB HALVERSON EXPLANATION, ADVISING THE ELIMINATION OF ONE FULL-TIME BASIC SKILLS EDUCATOR POSITION IN THE JUVENILE GOALS PROGRAM WILL ALLOW THE DEPARTMENT TO ENTER INTO AN AGREEMENT WITH MULTNOMAH EDUCATION SERVICE DISTRICT FOR SERVICES FOR ONE YEAR BEGINNING NOVEMBER 1, 2009. MR. HALVERSON ADVISED THAT DURING THIS FIRST YEAR THE DEPARTMENT AND MULTNOMAH EDUCATION SERVICE DISTRICT WILL PURSUE AGREEMENTS WITH LOCAL SCHOOL DISTRICTS TO PASS STATE FUNDS TO THE DISTRICT IN ORDER TO FUND THE DISTRICT FOR EDUCATION SERVICES TO YOUTH ASSIGNED TO THE DAY REPORTING CENTER. MR. HALVERSON ADVISED IT IS ANTICIPATED THESE AGREEMENTS WILL BECOME SELF-FUNDING THROUGH AVERAGE DAILY MEMBERSHIP DOLLARS FROM THE STATE.

CHAIR WHEELER AND COMMISSIONER KAFOURY EXTENDED THEIR THANKS.

BUDGET MODIFICATION UNANIMOUSLY APPROVED. [5-0]

COMMISSIONER MCKEEL MOVED AND COMMISSIONER COGEN SECONDED, APPROVAL OF THE SECOND READING AND ADOPTION.

BILL COLLINS, WITH DR. GARY OXMAN, PROVIDED A BRIEF EXPLANATION.

NO ONE WISHED TO TESTIFY.

ORDINANCE 1147 UNANIMOUSLY ADOPTED. [5-0]

R-5 First Reading of an ORDINANCE Amending the Multnomah County Flood Hazard Regulations to Adopt Updated Flood Insurance Rate Maps and to Incorporate Changes to the State's Model Flood Ordinance

COMMISSIONER SHIPRACK MOVED AND COMMISSIONER COGEN SECONDED, APPROVAL OF THE FIRST READING.

SENIOR PLANNER ADAM BARBER EXPLANATION, ADVISING MULTNOMAH COUNTY MUST SHOW EVIDENCE OF ADOPTING THE FLOOD INSURANCE RATE MAPS AND FLOOD INSURANCE STUDY BY DECEMBER , 2009 AS A CONDITION OF CONTINUED ELIGIBILITY IN THE NATIONAL FLOOD INSURANCE PROGRAM IN ADDITION TO THE ADOPTION OF FLOODPLAIN MANAGEMENT REGULATIONS THAT MEET THE STANDARDS OF THE NATIONAL FLOOD INSURANCE PROGRAM.

MR. BARBER ADVISED MANDATORY CHANGES TO THE REGULATIONS PROHIBITS NEW MANUFACTURED DWELLINGS IN THE REGULATORY FLOODWAY, UNLESS THE DWELLING IS REPLACING A LAWFULLY ESTABLISHED, EXISTING MANUFACTURED DWELLING; AND REQUIRES NEW MANUFACTURED DWELLINGS AND NEW STRUCTURES ACCESSORY TO MANUFACTURED DWELLINGS LOCATED ANYWHERE IN THE FLOODPLAIN TO BE ELEVATED 18-INCHES ABOVE THE FLOOD LEVEL AS OPPOSED TO THE CURRENT 12-INCH ELEVATION REQUIREMENT.

MR. BARBER ADVISED THE PROPOSED ORDINANCE CORRECTS DEFICIENCIES AND CHANGES; LIMITS REVIEW OF DEVELOPMENT WITHIN THE 1996-STORM INUNDATION AREAS TO LANDS INSIDE THE METRO JURISDICTIONAL BOUNDARY BECAUSE CURRENT CODE REQUIRES REVIEW COUNTYWIDE WHEN DEVELOPMENT IS PROPOSED IN AREAS INUNDATED IN 1996, WHICH EXCEEDS METRO TITLE 3 REQUIREMENTS AND RESULTS IN THE REGULATION OF LARGE PORTIONS OF SAUVIE ISLAND INSIDE THE FLOOD PROTECTION LEVEE. MR. BARBER REPORTED THE AMENDMENTS WERE DISCUSSED NUMEROUS TIMES DURING PUBLIC MEETINGS AND HEARINGS; AND ADVISED THE COUNTY'S PLANNING COMMISSION CAREFULLY CONSIDERED THIS ISSUE AND RECOMMENDS BOARD AMENDMENT OF THE PROPOSED ORDINANCE.

COMMISSIONER MCKEEL THANKED MR. BARBER FOR HIS WORK AND ASKED IF THERE WOULD BE ANY RISK OR DISRUPTION OF BUSINESS. MR. BARBER ADVISED NO BUSINESSES WOULD BE DISRUPTED; THAT ANY DISRUPTIONS WOULD BE TO MANUFACTURED HOME OWNERS WHO HAVE TO RAISE THEIR HOMES FROM 12" TO 18". MR. BARBER ADVISED THE FLOODPLAIN IS NOT IN A HIGH TRAFFIC AREA AND THERE ARE FEW DWELLINGS. MR. BARBER RESPONDED TO QUESTIONS OF CHAIR WHEELER AND COMMISSIONER SHIPRACK.

THE FIRST READING WAS UNANIMOUSLY APPROVED. THE SECOND READING IS THURSDAY, OCTOBER 29, 2009. [5-0]

ASSISTANT COUNTY ATTORNEY MATT RYAN, WITH DEPARTMENT OF COMMUNITY SERVICES PROGRAM MANAGER 2 JERRY ELLIOTT, ADVISED THE ATTORNEY FOR THE LAND SALE CONTRACT BUYERS REPORTED THAT THE BUYERS COULD NOT ATTEND TODAY'S BOARD MEETING AND ASKED FOR TIME TO PROVIDE ADDITIONAL INFORMATION. MR. RYAN ADVISED IT IS THE BOARD'S DECISION WHETHER TO PROCEED WITH THE CANCELANATION OR RESCHEDULE THE MATTER.
