The department is requesting board approval of budget modification DCM-04-15, reclassifying a GIS Cartographer Senior to GIS Cartographer in DART GIS/Cartography Program (72028).

DART is reorganizing in order to better align staffing guidelines as required by the Oregon Department of Revenue, utilize existing positions more effectively, adjust to increasingly technological change, meet span of control standards, and address succession planning, and risk litigation. This position is filled at this time.

The change impacts program offer 72028-15. This reclassification has been approved by the Class Comp section with an effective date of 7/23/2014.

There is a net savings in personnel of \$9,273, to be reallocated to supplies for this reclassification.
