## General Information

### 1. What action are you requesting from the Board?

Approval of the proposed settlement to acquire property interests from the City of Troutdale for the SE Troutdale Road Project.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

On June 28, 2012, the Board of County Commissioners approved Resolution No. 2012-083, directing the Department of Community Services to begin negotiations to acquire property for the constructing, maintaining, repairing, replacing, and reconstructing sidewalk and road facilities on a portion of SE Troutdale Road in the City of Troutdale. The Department of Community Services has contacted and conducted negotiations with the City of Troutdale for the acquisition of a portion of real property (1N3E36-00200). The proposed settlement amount is \$0.00.

### 3. Explain the fiscal impact (current year and ongoing).

The estimated project cost is less than \$100,000.00. Sufficient funds have been secured to proceed with final design and right-of-way acquisitions.

### 4. Explain any legal and/or policy issues involved.

The County will strictly follow the rules, policies, and procedures of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, ORS Chapter 35, the "State Right of Way Manual," and Multnomah County Procedure TRANS-01.

**5. Explain any citizen and/or other government participation that has or will take place.**

The County initially contacted the City of Troutdale in July 2012 concerning the potential acquisition of a portion of said real property (1N3E36-00200). The County has been in continuous contact with the City of Troutdale since then to ensure that all parties were aware of the project's schedule and the impacts to their real property. An administrative settlement, subject to Board Approval, was negotiated on August 30, 2012.
