R-6 RESOLUTION Consenting to Chair Appointment of Mary (Molly) Raphael as Director of the Multnomah County Library

COMMISSIONER CRUZ MOVED AND COMMISSIONER NAITO SECONDED, APPROVAL OF R-6, WITH THE ADDITION OF "AT THE SALARY OF \$120,000." TO THE END OF THE SENTENCE IN RESOLVE 1. CHAIR LINN PRESENTATION AND COMMENTS IN SUPPORT OF HER APPOINTMENT OF MS. RAPHAEL AND THE THIRTY YEARS' EXPERIENCE SHE WILL BRING TO THE POSITION. CHAIR LINN ADDED THAT SHE IS PROFOUNDLY DISAPPOINTED IN THE SALARY CONTROVERSY AND THAT SHE HOPES MS. RAPHAEL AND THE PUBLIC UNDERSTANDS THAT IT IS NOT ABOUT THE MERITS OF THE INDIVIDUAL. LIBRARY STAFF CRAIG CAPLING TESTIMONY ADVISING HE SUPPORTS THE LIBRARY DIRECTOR APPOINTMENT AND WANTS TO BRING ATTENTION TO THE PUBLIC THE BURDEN OF PART-TIME LIBRARY EMPLOYEES WHO WORK LESS THAN 32 HOURS, DO NOT RECEIVE BENEFITS, AND STRUGGLE TO RAISE FAMILIES ON BELOW LIVING WAGE SALARIES DUE TO MEDICAL COSTS. COMMISSIONER ROBERTS ADVISED HE SUPPORTS THE APPOINTMENT WITH THE AMENDMENT REGARDING THE REDUCED SALARY AMOUNT, AND THAT HE WILL BE REQUESTING THAT THE CHARTER REVIEW COMMITTEE LOOK INTO

CHARTER CHANGES REQUIRING BOARD APPROVAL OF THE SALARIES OF
CHAIR APPOINTED DEPARTMENT DIRECTORS. COMMISSIONER NAITO
COMMENTS IN SUPPORT OF THE AMENDMENT. RESOLUTION 03-134
UNANIMOUSLY ADOPTED, AS AMENDED.
