


Who We Serve




Organizational Chart




Budget by Fund – \$143,248,143

(Expenditures)




FTE by Fund – 799.12




Budget by Funding Source – \$28,470,218

Budget by Category - \$143,248,143 Total













- Systems beds are now at 1192 down from 1310 last year due to the closure of Dorms 4 & 5 at MCIJ

- Committed to DRO, NIC, CGJ recommendations (including mental health)




Corrections: *Population Trends*


Average Daily Population by Month



Standard Bookings





Average Length of Stay




- Elimination of the Warrant Strike Team to meet the FY 18 budget constraint

Enforcement: *Gun Violence Reduction Strategies*

Comprehensive approach centered on harm-reduction modeling:

- **Prevention** (suicide, accidental deaths)
- **Dispossession** (domestic violence, extreme risk protection orders)
- **Interdiction** (background check failures, firearm tracing investigations)

FIREARMS AND SUICIDE

Get trained to help
You can get trained to recognize the signs that someone needs help and take action. All you have to do is sign up online. Courses are free and open to the public.

two in five  **completed suicides use a firearm**

Mental Health First Aid
An eight-hour training that teaches how to recognize and respond to the signs and symptoms of a mental health crisis. Courses focus on youth and adults.

Question, Persuade, and Refer
A two-hour educational program teaching people how to recognize the early warning signs of suicide and connect a person at risk of suicide with someone who can help.

A.S.I.S.T.
A two-day, intensive workshop showing how to determine when someone is at risk for suicide, how to intervene, and connect people with recovery services.

Enforcement: *Warrant Strike Team*




- As of March 2017, Multnomah County has **11,015 active misdemeanor warrants** and **6,566 active felony warrants**
- Since its inception in October 2007, the Warrant Strike team has led 14,679 warrant service attempts and **cleared 4,036 warrants**



Enforcement: *Reason for HOPE*


- Respond to requests for assistance as first responders 24/7
- Reduce tension between community members and homeless
- Create a safe environment for service providers



- Ensure safety and health of homeless
- Remove dangerous predators/offenders
- Coordinate cleanup with inmate work crews



Business Services Division



Professional support services consolidated into Business Services as best practice and internal efficiencies

- Auxiliary Services Unit –Property & Laundry, Commissary, Purchasing & Warehouse – 31 FTE
- Alarms & Concealed Handgun Permits - 4.5 FTE
- Enforcement Support - 26 FTE
- Training - 8 FTE



Business Services: *Training Unit*

FY 2017

- 7 Training Staff
- 28 hours of training (Enforcement)
- 25 hours of training (Corrections)



FY 2018 (proposed)

- 8* Training Staff
 - Part-time instructors
 - Collaboration with PPB
- 40+ hours of Core Competency training
 - Mental Health First Aid
 - Trauma Informed Care
 - Medical First Aid
 - De-escalation
 - Tactics & Active Scenarios
 - Use of Force
 - Legal/Policy updates
 - Report Writing

*Two additional FTE will be assigned to ensure training is delivered (totals 10 Training Staff)






District 1 WST Activity






District 3 WST Activity 2007-2017
