WHEREAS, the Board of County Commissioners of Multnomah County, Oregon, having duly determined to initiate proceedings to surrender jurisdiction over all County Roads to the city of Portland within the areas annexed to the city of Portland effective June 30, 1991, as described in Boundary Change Final Order Nos. 2832, 2856, 2874, 2899, 2908, 2916, 2933, and 2934 of the Portland Metropolitan Area Local Government Boundary Commission;

WHEREAS, O.R.S. 373.270 grants authority for the County governing body to surrender jurisdiction of County Roads lying within the corporate limits of any city, it is hereby;

RESOLVED AND ORDERED that pursuant to the authority granted in O.R.S. 373.270, the Board of County Commissioners of Multnomah County, Oregon, hereby declares it is necessary, expedient and in the best interest of the County to surrender jurisdiction over said County Roads, to the City of Portland; and it is

FURTHER ORDERED, that the 19th day of December, 1991, at the hour of 9:30 a.m., in Room 602, Multnomah County Courthouse, Portland, Oregon, be fixed as the time and place for hearing the matter, and considering any objections or testimony offered by any person interested, and to determine whether it is necessary, expedient or for the best interest of the County to surrender jurisdiction over the following County Roads, to the City of Portland, within the areas annexed to the City of Portland effective June 30, 1991, as described in Boundary Change Final Order Nos. 2832, 2856, 2874, 2899, 2908, 2916, 2933, and 2934;
