Request the Board approve the reappointments of Katie Lane and George Feldman to the Multnomah County Library Advisory Board. Their 2<sup>nd</sup> terms will begin July 1, 2011 and end June 30, 2015.

The Library Advisory Board advises the Board of County Commissioners on matters relating to library services, policies and funding. It also serves as the Citizen Budget Advisory Committee for the County's Library Department. There are 17 members including two youth members (between the ages of 13 and 17). Non-youth members are appointed to 4-year terms by the County Chair with approval of the Board of County Commissioners. Youth members are appointed to 2-year terms by the County Chair with approval of the Board of County Commissioners.

The terms of two Library Advisory Board (LAB) members, Katie Lane and George Feldman are scheduled to expire June 30, 2011. Both are eligible for reappointment under the terms of Ordinance 649 which established the Library Advisory Board and limits Board members to two full consecutive terms. Each has indicated their willingness to be reappointed.
