At this time, Chairman Donald E. Clark and the Board gave a general welcome and congratulations to the newly appointed members of the Multnomah County Home Rule Charter Review Committee duly established through the Special Election held November 8, 1977. The Committee was formed for the purposes of reviewing the Home Rule Charter of Multnomah County, and to submit all amendments, if any, to the people of Multnomah County at the November 7th, 1978, General Election. Chairman Clark stated that \$25,000 was being earmarked as County financial support for the Committee through the mid-year budgeting process, and said the Committee should submit a budget to the Clerk. Copies of the Attorney General's Public Meetings and Records Manual as well as the current Home Rule Charter were available to all the members. He informed the Committee members that the Clerk of the Board would publish notice of their first meeting.
