1. Brief overview of grant's purpose and/or impact.

- In furtherance of its mission to deliver transportation safety programs to Oregon residents, the Oregon Department of Transportation (ODOT), Transportation Safety Division, has received federal funding from the National Highway Traffic Safety Administration, to support safety and efficiency opportunities for public safety agencies; specifically agencies that provide patrol enforcement focused on transportation safety priorities of impaired driving, occupant protection and speed control.
- ODOT grant programming is based on a complete and detailed problem analysis prior to the selection of projects. Motor vehicle crash data, survey results (belt use, helmet use, and public perception), and other problem identification data are analyzed. A broad spectrum of agencies at state and local levels and special interest groups are involved in project selection and implementation. Projects are selected using criteria that include response to identified problems, innovation, clear objectives, adequate evaluation plans, and cost effective budgets. Approved public safety agencies may then apply for *reimbursement* of project expenses.
- The Multnomah County Sheriff's Office (MCSO), Law Enforcement Division, provides patrol services to unincorporated Multnomah County, as well as four (4) contract cities. The Patrol Unit is seeking monies to fund overtime for enhanced speed enforcement first and the use of mobile electronic devices while driving second, to comply with existing ORS provisions and recently enacted state law (HB 2597).

- ODOT and MCSO will review the state's crash-related data with emphasis on high speed-related issues (e.g. fatalities, serious injuries) to identify target locations for speed-related enforcement. Locations such as I-84, US 30, US 26, and MCSO's contract communities of Troutdale and Fairview, are projected locations of interest.
- From there, traffic safety missions will be devised to meet the end goal of ensuring MCSO's law enforcement members implement coordinated/preplanned details at specified locations and to make up to three (3) enforcement contacts per hour of individual overtime worked. To achieve the desired outcomes of reducing crashes, serious injuries and deaths, MCSO may coordinate with additional jurisdictions under this agreement, including Portland Police, Gresham Police, and/or Clackamas County Sheriff's Office.
- Based on overtime activity, MCSO will provide ODOT with enforcement data monthly to confirm locations worked and outcomes (e.g. stops/warnings/citations related to speeding, use of electronic mobile devices, DUII, use of seat belt, etc.). Additionally, MCSO will utilize this data to complete media outreach, advertising roadways targeted, post enforcement results, and tips for desired driving behavior. ODOT will evaluate and incorporate MCSO's data into their overall traffic safety enforcement programming for future innovation.
- Applying for this funding keeps with MCSO's commitment to provide service excellence and practice fiscal responsibility. Therefore MCSO intends to request \$15,000 in Transportation Safety funds, to be matched by \$3,750 in Agency funds, for a total of \$18,750, which may be applied towards overtime accordingly.

2. Brief overview of how proposal is aligned with Department's strategic direction.

- The primary mission of MCSO is public safety in accordance with public trust. With Patrol Unit members conducting traffic safety missions, it will improve member response to public safety incidents (e.g. traffic collisions, impaired driving, occupant protection and moving violations, etc.) within its jurisdiction and coordination intergovernmentally, thereby furthering the trust of the public in law enforcement services and transportation safety.

3. Describe any community and/or government input considered in planning for this grant.

- As noted, ODOT pursues a broad spectrum of agencies at state and local levels and special interest groups in the selection of projects and to monitor its implementation.

4. What partners may be included in program activities?

- Discussions will continue between MCSO and ODOT to ensure collective safety and efficiency goals are met. Additionally, MCSO will continue to build valuable relationships with partnering public safety entities as it implements data-driven traffic enforcement missions.

5. Generally, what are the grant's reporting requirements?

- While this project is operational, monthly requirements are placed on MCSO. The MCSO Patrol Unit Manager will submit a claim for reimbursement to ODOT detailing the specific missions implemented, expenses incurred, supporting documentation and the amount of reimbursement requested. This data will enable ODOT to conduct a project evaluation and inform future invocation. ODOT reimbursement to MCSO will occur on a quarterly basis. MCSO's project information currently relates to ODOT Project No. SC-18-35-11-MCS.

6. When the grant expires, will your Department continue to fund the program? If so, how?

- MCSO will continue to fund the Patrol Unit; the true costs of this project are the upfront overtime expenses, which will be largely covered by this grant.
