tabulation attached as Exhibit A,



Dear Ms. Smith, Mr. Lutz, Ms. Hanson and Ms. Parker:

Effective August 31, 2009, there is a vacancy in House District 35 due to the resignation of State Representative Larry Galizio. The letter of resignation was received in our office on August 19, 2009. Since the letter of resignation was filed with a future date of August 31, 2009, we must allow three business days for the legislator to rescind his resignation.

Pursuant to ORS 171.060(1), you are hereby notified of the vacancy. ORS 171.051(2) requires each nominee to be a citizen qualified to hold the office, an elector of the 35th representative district and a member of the Democratic Party for 180 days prior to the date of the vacancy (3/4/09). In addition, Article IV, section 3 of the Oregon Constitution requires that the appointee shall have been an inhabitant of the district for at least one year prior to the date of the appointment. It is the responsibility of the Democratic Party to ensure that all nominees meet these qualifications before the submission of the "Willingness to Serve" statements to the Secretary of State.

You are advised the same statute requires the party central committees within the district to nominate no fewer than three nor more than five qualified persons to fill the vacancy. The nominating convention shall be conducted according to party rules.

You are required by law to notify the Secretary of State of the persons nominated. The nominations must be made no later than **September 20, 2009**, 20 days after the vacancy occurred.

The notification to the Secretary of State shall be accompanied by the signed written statement of each nominee indicating that the nominee is willing to serve in the office of State Representative, District 35. Copies of the statement are enclosed (SEL Form 145a).



The vacancy must be filled by appointment not later than September 30, 2009, thirty days after the vacancy occurred.

The total number of registered electors in House District 35 as of 5:00 p.m. on August 31, 2009, is 2,681 in Multnomah County and 33,364 in Washington County. In accordance with ORS 171.062 each county is entitled to one vote for each 1,000 registered electors or major fraction of 1,000 (more than 500 registered electors, but less than 1,000) and each county commissioner is allotted the following number of votes:


Multnomah County:	2,681 or 3 votes divided by 5 = $3/5$ votes per commissioner
Washington County:	33,364 or 33 votes divided by 5 = $6 \frac{3}{5}$ votes per commissioner

These votes are apportioned to each county commissioner. If for any reason a county commissioner is unable to attend the meeting on September 21, 2009, that county commissioner's vote would not be cast. The votes are not reapportioned for the remaining county commissioners to cast.

Enclosed is a copy of the Administrative Rule outlining the procedures for the conduct of a meeting to fill a vacancy in the Legislative Assembly. Also enclosed is a Statement which you may use to notify the Secretary of State of the appointment, which includes a signature sheet and a vote tabulation sheet. You may produce and use your own version of these documents if you wish. The completed Statement, signature sheet and tabulation sheet must be returned to this office as soon as possible after the meeting.

RULE SUMMARY

- 165-010-0005** – This rule adopts the 2004 *State Candidate's Manual: Major Political Party*; 2004 *State Candidate's Manual: Nonpartisan*; 2004 *State Candidate's Manual: Minor Political Party*; 2004 *State Candidate's Manual: Assembly of Electors*; 2004 *State Candidate's Manual: Individual Electors*; and the 2004 *County Candidate's Manual* and associated forms as the procedures and forms to be used by candidates filing and running for elected office. In addition this rule designates the 2004 *State Candidate's Manual: Minor Political Party* to be used for the formation of a Minor Party. Each manual has been updated from the 2002 version.
- 165-010-0060**– This rule amendment clarifies the procedure for filling a legislative vacancy.
- 165-010-0080** – This rule updates form SEL 141, the Write-In Candidate Acceptance Form.
- 165-010-0090** – This amendment deletes the portion of the rule that repeats statutory requirements.

Procedure for Conduct of Meeting to Fill Vacancy in Legislative Assembly

The following procedures govern the conduct of a meeting of a county court or board of commissioners (hereafter, county governing body(ies)) to fill a vacancy in the Legislative Assembly. These meeting procedures apply to appointments made under either ORS 171.060(1) (vacancy to be filled by nominee affiliated with a major political party) or ORS 171.060(2) (vacancy need not be filled by member of a particular major political party).

(1) A meeting of the members of the county governing body(ies) shall convene at the time designated by the Secretary of State. If the legislative district includes more than one county, the Secretary of State shall also name the temporary chairperson for the meeting and designate its location, which shall be within the legislative district. The Secretary of State shall also notify the county governing body(ies) of the nominees and of the number of votes apportioned to each member of the county governing body(ies) under ORS 171.062 and 171.064.

(2) The chairperson conducting the meeting shall open the meeting at the time designated by the Secretary of State. The chairperson shall announce that the purpose of the meeting is to appoint a person to fill the vacancy in the Legislative Assembly. If applicable, the appointment will be made from the list of nominees from the major political party as furnished by the Secretary of State.

(3) Members of the county governing body eligible to vote on the selection are those physically or electronically present at the meeting, who are currently holding office by election or appointment.

(4) The county governing body(ies), in making its determination, may allot time for interviewing nominees or applicants and for other pertinent deliberations prior to voting.

(5) The vote shall be taken in a manner specified by a majority of those present and eligible to vote on the selection. The person receiving the highest number of votes shall be the appointee. However, in any case, the vote of each member of the governing body(ies) shall be recorded and included in the written statement required by ORS 171.060(3).

(6) The Secretary of State hereby adopts forms SEL 145a, Statement of Democratic Nominee's Willingness to Serve, and SEL 145b, Statement of Republican Nominee's Willingness to Serve, as the forms to be used to accept a nomination to fill a legislative vacancy.


Multnomah County: 2,681 or 3 votes divided by 5 = $3\frac{3}{5}$ votes per commissioner
Washington County: 33,364 or 33 votes divided by 5 = $6\frac{3}{5}$ votes per commissioner

These votes are apportioned to each county commissioner. If for any reason a county commissioner is unable to attend the meeting on September 21, 2009, that county commissioner's vote would not be cast. The votes are not reapportioned for the remaining county commissioners to cast.

Enclosed is a copy of the Administrative Rule outlining the procedures for the conduct of a meeting to fill a vacancy in the Legislative Assembly. Also enclosed is a Statement which you may use to notify the Secretary of State of the appointment, which includes a signature sheet and a vote tabulation sheet. The completed Statement, signature sheet and tabulation sheet must be returned to this office as soon as possible after the meeting.

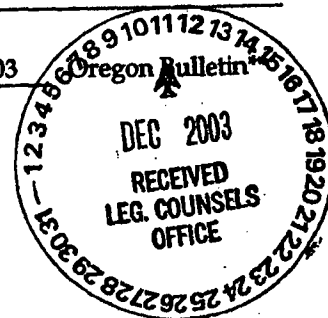
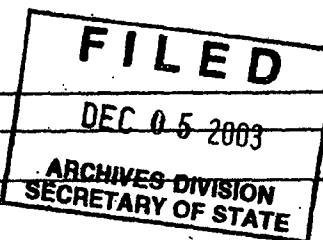



Re: *Results of Nominating Convention; Reasons for Seeking Office*

I. Results of the Nominating Convention

The Democratic Party has presented the commissioners with three outstanding candidates to replace Rep. Galizio. Each would do a fine job representing Oregon's 35th District in the Oregon House—which leaves the Washington and Multnomah County Commissioners with a difficult decision. These difficult decisions are typically assisted by the party's nominating convention, but this nominating convention provides little help to the commissioners as no clear front runner emerged. The results of the convention were as follows:

- 1st Place: Margaret Doherty 43%
- 2nd Place: Dylan Hydes 42%
- 3rd Place: Steve Dunne 15%

No candidate left the convention with a majority of the votes and the top two candidates were separated by approximately ½ of one PCP's votes. Such a situation would certainly seem to warrant a runoff, but the convention rules do not provide for such a procedure.

I understand that the Commissions most often choose the candidate that emerges from the convention with a plurality of the votes, but I would ask the Commissioners to refrain from this practice for three reasons. First, the party was unable to provide a consensus candidate to the Commission. Second, I believe that despite receiving 1% less of the vote than my nearest opponent, I am the best person for this job. And third, and most important, the amount of support I have built over a 27-day period is nothing short of amazing.

I first learned of Rep. Galizio's retirement while I was getting ready for work. I had the radio on that morning while I heard that not only was Rep. Galizio retiring, but he had already endorsed his successor. Rep. Galizio's seat is one that I had been eyeing for some time, but I respected Rep. Galizio and liked the job he was doing in Salem so I decided years ago that I would wait to make a run until the seat became open. So when I heard that Rep. Galizio was retiring and that I had 27 days to mount a campaign against a challenger who had already received the outgoing candidate's endorsement was, to be honest, I was more than a little

disappointed. However, instead of giving up I became informed and quickly organized. In those 27 days I learned that this extremely brief campaign would not be about raising money or knocking on doors, but getting to know the 35 PCP's whom I had never met before and who my opponent had already been in contact with and created relationships. I sent every PCP a letter; I placed at least one phone call to every PCP; and I sent every PCP at least two emails. Every PCP who responded to my communications or returned my phone calls received a rapid response from me and offers to meet in person and discuss the issues important to them, the district and the state of Oregon. I then began forging critical relationships with the approximately one-half of the PCP's that gave me the opportunity to meet them and the results speak for themselves. I, Dylan Hydes, a person who 27 days prior was a complete unknown to the PCPs, won the support of, if not every PCP I met with, very nearly every PCP I met with.

My closest opponent for this office has an amazing record. She has taught public school for 10 years, worked for the OEA for 20 years, served on the Tigard planning commission and won the endorsement of the outgoing, and very popular holder of this seat. Despite this impressive record and the institutional advantages at her disposal, I was able to, in my short 27-day campaign, garner nearly as much support as my chief opponent. Had this campaign been any longer, say 2 months, or I was notified in some way of Rep. Galizio's retirement prior to that morning on the radio, I believe it would indeed be my opponents would be arguing today for the Commission to put aside the results of the nominating convention.

II. Reasons for Seeking the Appointment to HD-35

I have been passionate about politics, public policy and the legislative process my entire life. I grew up in John Day, Oregon. In that town, a lot of kids wanted to be loggers or truck drivers or professional athletes, but I wanted to serve in government. The reason for my passionate commitment to this career at such a tender age is that I am an Idealist. I firmly believe there is no greater way to improve the lives of Oregonians and Americans than through government action, and in some circumstances, government *inaction*.

One reason why I am strong candidate for state legislature is that I am a student of public policy and a bit of a policy wonk. However, I am still able to talk about complex issues in a way that most anyone can understand. This is a skill I learned teaching 7th and 8th Grade Social Studies for four years. I further honed this skill talking to juries while working in Multnomah County District Attorney's Office. Further, my knowledge goes beyond just my professions—education and the practice of law—and that is what every legislator needs to be, a jack of all trades and hopefully a master of some. It does little good to have a legislator who is an expert in one area, but knows little else. I have a broad and deep understanding of many of the issues facing Oregon and the 35th District. To those issues in which I am not expert, I have the curiosity, drive and ability to learn about them.

The 35th District is divided very closely between Democrats and Republicans. I believe my experience and biography make me an ideal candidate to serve such a district for four reasons. First, while I am a proud Democrat, I am not an ideologue. If I disagree with my party I

will say so—just as I would if I disagreed with the Republican Party. My pragmatism is well demonstrated by career choices. While I believe in protecting the rights of the accused, I very much enjoyed my time prosecuting criminals in the district attorneys' office. And while I strongly believe in one's right to bring a lawsuit if they are injured, my current career is spent defending businesses and insurance companies from lawsuits. Second, I am not beholden to any special interests group. For example, while I strongly support the teachers' union, I believe they are wrong to categorically oppose merit pay. Third, there are issues in which my beliefs are not entirely consistent with my party and which conservatives are able to identify with, such as gun control and illegal immigration. And fourth reason I am a good fit for my district is that I grew up in John Day, Oregon, the center of the most conservative county in the entire state. Growing up there made me appreciate the value of diverse thinking and it taught me how to communicate, respect and work with those with whom I disagree.

My commitment to public service and political involvement cannot be questioned. Since the age of 21 I have been active in politics either professionally or as a volunteer, as my resume indicates. My first job out of college was in the office of Congressman David Wu. As a teacher I did my best to inspire my students to become active citizens (as demonstrated in the newspaper article I submitted with my materials). As an attorney and family man my life is very full, but I continue to make time for political involvement.

As a representative to HD-35 I would fight for those issues that I am passionate about and that very much impact the district and our state. Those things include: funding education and public safety without slashing services to the neediest among us; finding ways to fuel economic growth and attract businesses to the area without harming the environment or destroying what makes Oregon and Washington County so appealing and livable; and working with local communities and the federal government to find ways of improving traffic congestion.

III. Conclusion

The Commissioners have a choice between three tremendous candidates to replace the outgoing representative of House District 35. I simply ask that the commissioners select the candidate they believe will best serve the district and not rely solely on the results of a nominating convention that was unable to put forth a consensus candidate. I believe that I am the best candidate to represent the diverse district that is HD-35 and I respectfully request your support on September 21.

Dylan Hydes' eighth grade social study classes at Castillero Middle School are learning all about the political process in America. And not just from books and lectures. Hydes' innovative program has them volunteering for the party of their choice.

"I knew three years ago when I started teaching that in 2004 my students in some way would be involved in the election," Hydes, a self-proclaimed political junkie, commented about the curriculum. "That is an essential theme in my classroom. Our society and political system can only sustain itself with informed and active citizens. Voting is important, but we should be asking much more of all people than simply voting, as I am asking more of my students."

Hydes' innovative program presented students with volunteering for the Democratic, Republican or a party of their choice. Before they decided, the class examined the philosophical differences between the two main parties and dissected their platforms. As a stimulus to volunteer, Hydes offered 20 points of extra credit to his five classrooms of 156 eighth grade pupils. A total of 69 attended the first event at the Santa Clara Democratic Headquarters on Almaden Road. Their activities for the two-hour volunteer effort included writing letters to swing states, preparing voter registration forms, making campaign posters, writing notes to remind people to vote and preparing giveaway bags for precinct walkers. Parents were encouraged to watch or participate.

"This is a great way for the kids to learn the whole political process," Almaden resident Mary Loveless remarked as she watched her daughter, Patricia, stuffing bags with Democratic campaign items with her school friends. "It is a great opportunity for her to learn the contrasts between the two parties."

"Our children are lucky to have teachers such as Mr. Hydes to teach them the democratic process and to listen to all sides prior to making decisions," Marjorie Stiles, mother of Jessie Newman said. "It's nice to be able to talk to my daughter about issues and candidates and she has actually advised me on a few things that have changed my mind."

The 13 and 14 year olds were just as energized as the parents.

"It's a good way for kids to get involved," Sarah Anderson said while cutting paper for posters to be distributed to retail outlets. "And it makes you feel good to help."

"We heard about this in Mr. Hydes' class," David Hoyt remarked, taking a break from writing letters about environment concerns to voters. "We also set up an election with campaign managers and groups of the different parties. It's all very interesting."

And they have political preferences.

"Bush is not doing enough for the country," Mike McCormick answered to why he volunteered. "We're \$7 billion in debt. He said he'd do all these things and we're still waiting. It outrages me."

"We should look for what we believe in," Eric Beutler chimed in. "And influence other people to vote."

"I believe in most of the stuff that Democrats believe in," Greg Edwards said solemnly.

"That's why I'm here."

When Jessie Newman was asked why she got involved in the Democratic volunteering effort, she immediately said,

"Because of Bush and Mr. Hydes—he's an awesome teacher."

Hydes' enthusiasm for politics began early in his life. He served as a delegate to the 1999 College Democratic Convention in Washington, D. C. This year, he was chosen as a first-time delegate at the Democratic National Convention in Boston, Mass. He hopes that the volunteer effort of his eight graders will build a foundation for a lifetime of volunteerism, informed choices, and keeping the government accountable.

"All students were given the opportunity to volunteer for either the Republican or Democratic parties," said the 26-year-old Hydes. "It is our civic responsibility to make informed decisions based on the issues and positions of the candidates and not be swayed by glitzy ad campaigns or the mood of the day."

Ron Naymark, a member of the speaker's bureau for the Democratic Headquarters, spoke to the students about the importance of voting.

"Why is it important to vote?" Naymark asked the interested group.

"Because one vote could change who is president," one of the teenagers answered.

"That's right," Naymark continued. "You're going to learn how to run a political campaign here and I know there is at least one person here, probably more who has the capability of becoming a governor, senator or even president one day."

Nancy Pyle, candidate for Council Member, District 10, made a special visit to the volunteer effort offering a personal approach to the political race for the enthusiastic crowd.

"One of the best things I ever did was teach school," said Pyle, who at one time taught at Castillero. "You are part of the reason I'm running. We have to get serious about helping our schools. We need to ask our government to form a partnership in San Jose Unified School District and the corporate world. There's a lot they can do to help and there's no time like now."

The excited volunteers continue their work generating campaign tools as they chat and laugh among themselves.

The program has been a success and the students have a better understanding of the political process due to a motivated educator.

Hydes is in negotiations to arrange space at the Santa Clara Republican Headquarters for a volunteer effort with interested students but as of yet, no date has been set.
