Approval of staffing adjustment resulting from the re-classification of two positions. This change will not impact the Health Department's total FTE for FY2011.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Reclassify a 1.0 Clinical Services Specialist to a 1.0 Health Educator, position 714403, in the Integrated Clinical Services Division of the Health Department. Class Comp approved reclassification effective on 12/23/2010 (reclass #1651). The purpose of this position is to perform health education and medical case management involving assessment and analysis of complex psycho-social factors and coordination of specific case plans to meet health education and psycho-social needs of patients of HIV Health Services Center.

This change impacts program offers 40012 – Services for Persons Living with HIV.

Reclassify a 0.92 Environmental Health Specialist to a 0.92 Environmental Health Specialist Senior, position 714965, in the Community Health Services Division of the Health Department. Class Comp approved reclassification effective on 01/01/2011 (reclass #1646). This position conducts special investigations in areas such as health and nuisance violations and performs mediation in cases of conflict between Environmental Health Specialists and facility operators. In addition, this position will provide input on budget development, participate in budget preparation, anticipate future needs and monitor and control budget expenditures.

This change impacts program offers 40007 – Health Inspections & Education.
