General Information

1. What action are you requesting from the Board?

- The Multnomah County Sheriff's Office (MCSO) respectfully requests Board of Commissioners approval of Intergovernmental Agreement-31957, which authorizes MCSO to conduct commercial motor vehicle (CMV) inspections and enables the State of Oregon Department of Transportation (ODOT) to reimburse MCSO for this effort.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

- Intergovernmental Agreement-31957 will reimburse MCSO for the time its Patrol Unit members spend conducting CMV inspections in support of the Oregon Motor Carrier Safety Action Plan (MCSAP), which aims to reduce accidents involving CMVs, and therefore traffic injuries and fatalities.
- Intergovernmental Agreement-31957 relates to Program Offer 60063-18, Patrol Unit. Generally, MCSO's Patrol Unit members are responsible for the protection of Multnomah County residents and recreational visitors via emergency response, patrol, traffic education and enforcement. The Patrol Unit further provides emergency preparedness,

assistance and intervention as part of the treatment service continuum. Patrol deputies and sergeants develop and implement community policing projects utilizing community based policing principles and frontline human services while providing safety to residents.

3. Explain the fiscal impact (current year and ongoing).

- Per Intergovernmental Agreement-31957, ODOT will reimburse MCSO an amount not to exceed \$70,000 for CMV inspections in Fiscal Year 2018.

4. Explain any legal and/or policy issues involved.

- Intergovernmental Agreement-31957 has been reviewed by the County Attorney's Office. Pursuant to ORS 825.248, ODOT is required to develop an annual commercial motor vehicle safety plan, referred to as the MCSAP, which aims to reduce accidents involving commercial motor vehicles, and therefore traffic injuries and fatalities. On-road vehicle inspections focus on conditions that could require the vehicle and/or its operator to be taken out of service, thus reduce at-fault crashes on Oregon highways.
