It further appearing that said property is desirable for use as a part of the road system of Multnomah County, and that the Director of the Department of Environmental Services has recommended that said deed be accepted and said property accepted and established as a county road;

NOW, THEREFORE, IT IS HEREBY ORDERED that the deed of R. Dale Haney, conveying to Multnomah County, the following described property, to be known as Palmquist Road, County Road No. 608, situated in the County of Multnomah, State of Oregon, to-wit:

A parcel of land situated in the northeast one-quarter of Section 14, T1S, R3E, W. M., Multnomah County, Oregon, being more particularly described as follows:

The north 15.00 feet of that tract of land conveyed to Alco Development Co. Inc., by deed recorded December 10, 1986, in Book 1962, Page 1218, Deed Records of Multnomah County, Oregon, which is described as follows:


Beginning at a point 25.00 feet south and 100.00 feet east of the northwest corner of the east half of the west half of the southwest quarter of the northeast quarter of said Section 14, said point being on the south line of Palmquist Road (County Road No. 608); thence S 0°12'05" E parallel with the west line of the east half of the west half of the southwest quarter of the northeast quarter of said Section 14, 171.00 feet; thence S 89°42'10" E parallel with said Palmquist Road, 117.72 feet; thence N 00°15'47" W, 171.00 feet to a point on the south line of said Palmquist Road; thence west along said south line of Palmquist Road 117.54 feet to the point of beginning, EXCEPTING THEREFROM the west 80.50 feet of the north 87 feet.


