BOARD BRIEFING

Vice-Chair Judy Shiprack convened the meeting at 10:09 a.m. with Commissioners Jeff Cogen and Deborah Kafoury present, and Commissioner Diane McKeel and Chair Ted Wheeler excused.

B-1 Housing Alliance (HAP) Update. Presented by Janet Bryd.

MS. BYRD PRESENTATED AN UPDATE ON THE HOUSING ALLIANCE AND RESPONDED TO BOARD QUESTIONS AND COMMENTS.

IN EFFECT SINCE 2004, HAP CONNECTS NON-PROFIT MEMBERS INCLUDING LOCAL GOVERNMENTS, HOUSING AUTHORITIES, SERVICE PROVIDERS AND OTHER ADVOCATES WITH COMMUNITY GROUPS, ENVIRONMENTALISTS, BUSINESS INTERESTS, AND OTHERS CONCERNED ABOUT OREGON'S SHORTAGE OF AFFORDABLE HOUSING. HAP FUNCTIONS THROUGH MEMBER DUES, OF WHICH MULTNOMAH COUNTY IS A MEMBER AND PAYS \$3500 ANNUALLY.

SHE DISCUSSED THEIR LEGISLATIVE ACCOMPLISHMENTS SINCE 2005 AND HOW THEIR WORK IMPACTS THE COUNTY. PRIORITIES FOR 2010 ARE: IMPLEMENTING HOUSE BILL 2436 AS A NEW REVENUE SOURCE WHICH INCREASES THE EXISTING STATE DOCUMENT RECORDING FEE BY \$15; NEW REVENUES DEDICATED TO AFFORDABLE HOUSING; PROTECTION OF FUNDING FOR EMERGENCY HOUSING; AND EXTENDING SUNSETS ON TWO STATUTES AUTHORIZING PROPERTY TAX EXEMPTIONS. THEY ARE WORKING WITH ALL

COUNTIES AND JURISDICTIONS TO COME UP WITH APPROACHES TO SATISFY EVERYONE'S CONCERNS. SHE THANKED THE COMMISSIONERS FOR THEIR SUPPORT AND WELCOMED THEIR INVOLVEMENT.

THE COMMISSIONERS THANKED HER FOR HER REPORT.

B-2 PROCLAMATION Proclaiming Tuesday, December 1, 2009 as World AIDS Day in Multnomah County, Oregon. Presented by Michael Kaplan, Executive Director, CAP; Kim Toevs; Multnomah County HIV/Hep C Manager; Loretta Slader, Yvonne Williams, A-6; and Dean Bennett, CAP (Cascade AIDS Project) at CHAMP

COMMISSIONER KAFOURY MOVED AND COMMISSIONER SECONDED, APPROVAL OF B-2.

COMMISSIONER SHIPRACK, MICHAEL KAPLAN, EXECUTIVE DIRECTOR OF CASCADE AIDS PROJECT (CAP), AND KIM TOEVs, MULTNOMAH COUNTY HIV/HEPATITIS C MANAGER EXPLAINED THE IMPORTANCE OF THIS PROGRAM. SINCE DECEMBER 1, 1988, MULTNOMAH COUNTY HAS PROCLAIMED THIS DAY AS WORLD AIDS DAY IN MULTNOMAH COUNTY, OREGON IN ORDER TO RAISE MONEY, INCREASE AWARENESS, FIGHT PREJUDICE AND IMPROVE EDUCATION. 2009'S FOCUS IS "UNIVERSAL ACCESS AND HUMAN RIGHTS."

MICHAEL KAPLAN SPOKE OF THE WORK ONGOING AT CAPS' HIV CLINIC; THE HIGHER NUMBER OF PEOPLE LIVING WITH AIDS IN AMERICA, THE DISPROPORTIONATE SHARE OF NEW INFECTIONS AMONG PEOPLE OF COLOR, GAY AND BISEXUAL POPULATIONS; AND THE IMPORTANCE OF EDUCATION, INCREASING ACCESS TO HEALTH CARE, AND RAISING AWARENESS.

LORETTA SLADER TALKED OF HER WORK IN THE PREVENTION OF HIV SINCE THE 1980's AND IMPORTANCE OF MAKING PEOPLE AWARE OF THIS DISEASE EVERY DAY, PREVENTING COMPLACENCY, THE IMPORTANCE OF TESTING AND TALKING ABOUT SEXUAL HEALTH.

YVONNE WILLIAMS TALKED ABOUT HER WORK ON THE AFRICAN AMERICAN AIDS AWARENESS ALLIANCE, A GROUP OF COMMUNITY ORGANIZATIONS COLLABORATING TO BRING AWARENESS OF THE AIDS EPIDEMIC THAT PLAGUES THE AFRICAN AMERICAN COMMUNITY, AND THEIR ONGOING WORK TO PROVIDE RESOURCES, EDUCATION, AND OFFER TESTING.

DEAN BENNETT TALKED ABOUT CLINIC HEALTH ACCESS AND MENTORING PROJECT (CHAMP) AND THEIR ONGOING WORK AS MENTORS ONE-ON-ONE, HELPING PATIENTS LEARN TO COPE AND LIVE WITH THE DISEASE.

KIM TOEVS DISCUSSED THE WORK THEY ARE DOING AT THE HIV/HEPATITIS CLINIC AND THEIR EFFORTS TO OBTAIN GRANTS TO EXPAND THEIR WORK. SHE INVITED THE COMMISSIONERS TO THE EVENTS ONGOING TODAY.

THE COMMISSIONERS THANKED HER FOR HER REPORT.
