General Information

1. What action are you requesting from the Board?

- The Multnomah County Sheriff's Office (MCSO) respectfully requests time to update the Board of Commissioners on the work of the Training Unit and Agency programming.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer(s) this action affects and how it impacts the results.

- The Oregon Department of Public Safety Standards and Training (DPSST) mandates that all law enforcement and corrections members complete required training elements to receive and maintain certification through the State of Oregon. MCSO's Training Unit is responsible for the administration of a comprehensive Training Program that provides for certification requirements, in addition to the professional growth and continued development of all sworn members as required by law, policy mandates, community expectations, member assignments and resources. In managing training, the Training Unit plays a significant role in ensuring members possess the knowledge and skills necessary to provide a professional level of service that meets community needs and furthers the safety of members and the community alike.
- MCSO is looking anew at its training efforts. The Training Unit is conducting an annual assessment of the training needs within our Agency, which is informed by a variety of matters such as best practice, new mandates, policy revisions, and Agency trends, among others. From there an Annual Training Plan is devised identifying who will receive training, what course materials will be presented and how, when and where training will occur and supporting rationale

for the effort. The effectiveness of training offered is evaluated to improve upon future instruction and quality of course curriculum, as well as to measure student satisfaction, comprehension and ultimately application of the knowledge and skills acquired in training to the demands of each post. This briefing will provide the Board of Commissioners with an overview of public safety training that has been provided over the past year and MCSO's future intentions.

3. Explain the fiscal impact (current year and ongoing).

- Training Unit funding is a part of the MCSO annual budget and will be a future budget consideration, as Multnomah County is responsible for providing professional public safety services in support of our community.

- In managing training, the Training Unit plays a significant role in ensuring members possess the knowledge and skills necessary to provide a professional level of service that meets community needs and furthers the safety of members and the community alike.
