BEFORE THE BOARD OF COUNTY COMMISSIONERS

Ordinance No. 79

An ordinance amending Section 13 of Ordinance No. 100 to increase the fee schedule for certain applications, and declaring an emergency.

Multnomah County ordains as follows:

Section 1. Policy.

- A. The Board of County Commissioners of Multnomah County, Oregon recognizing that the zoning ordinance is in need of periodic revision and amendment to improve the zoning ordinance, and in the interest of public health, safety and general welfare of Multnomah County citizens, the Board does hereby determine the necessity of amending the zoning ordinance as hereinafter more particularly described.
- B. The Board further determines and takes public notice that the Planning Commission of Multnomah County, Oregon has initiated and proposed this change, and has recommended to the Board of County Commissioners that this amendment be enacted.

Section 2. Amendment.

Section 13 of Ordinance No. 100 is amended by deleting subsections 13.01, 13.02 and 13.03 which read:
