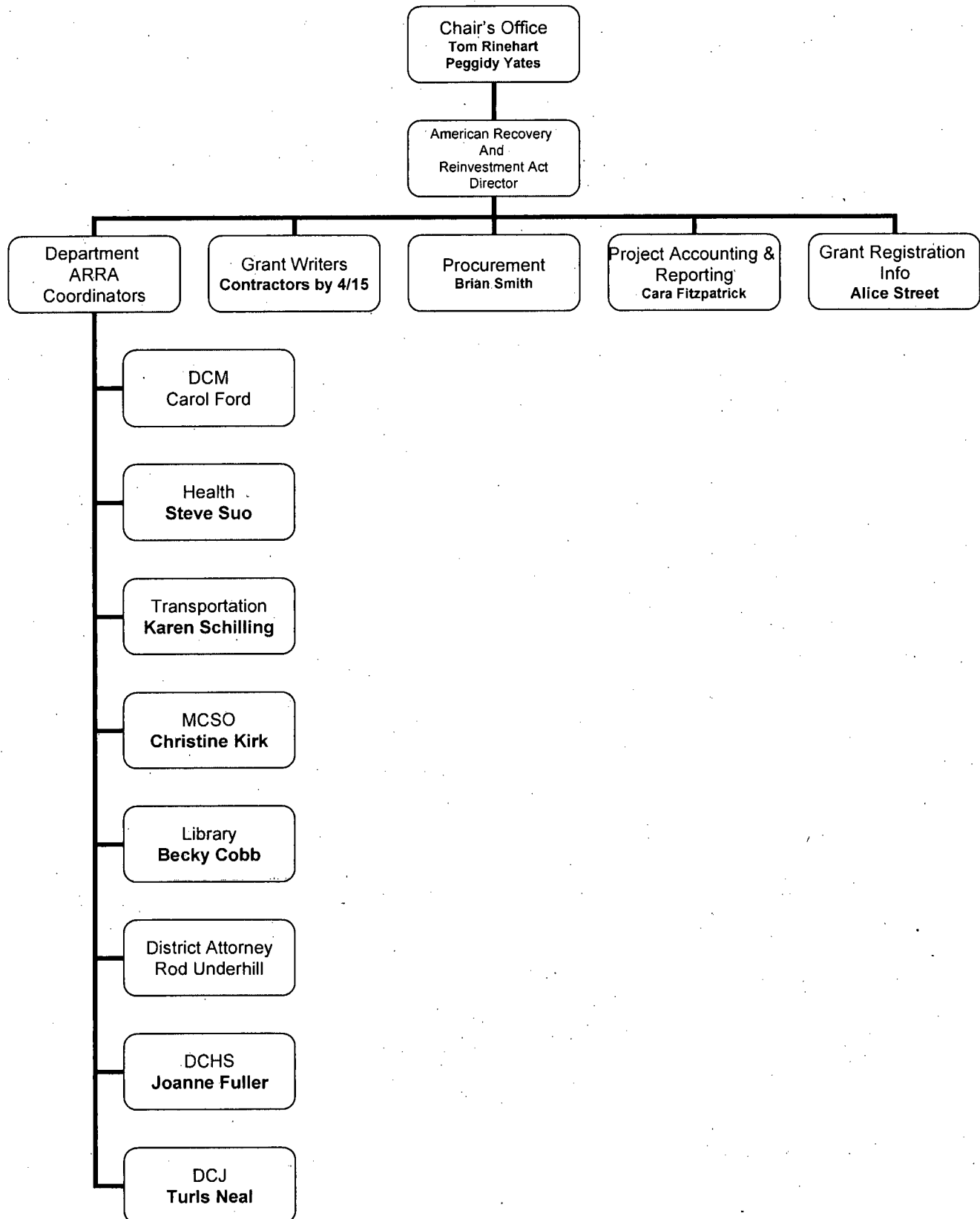

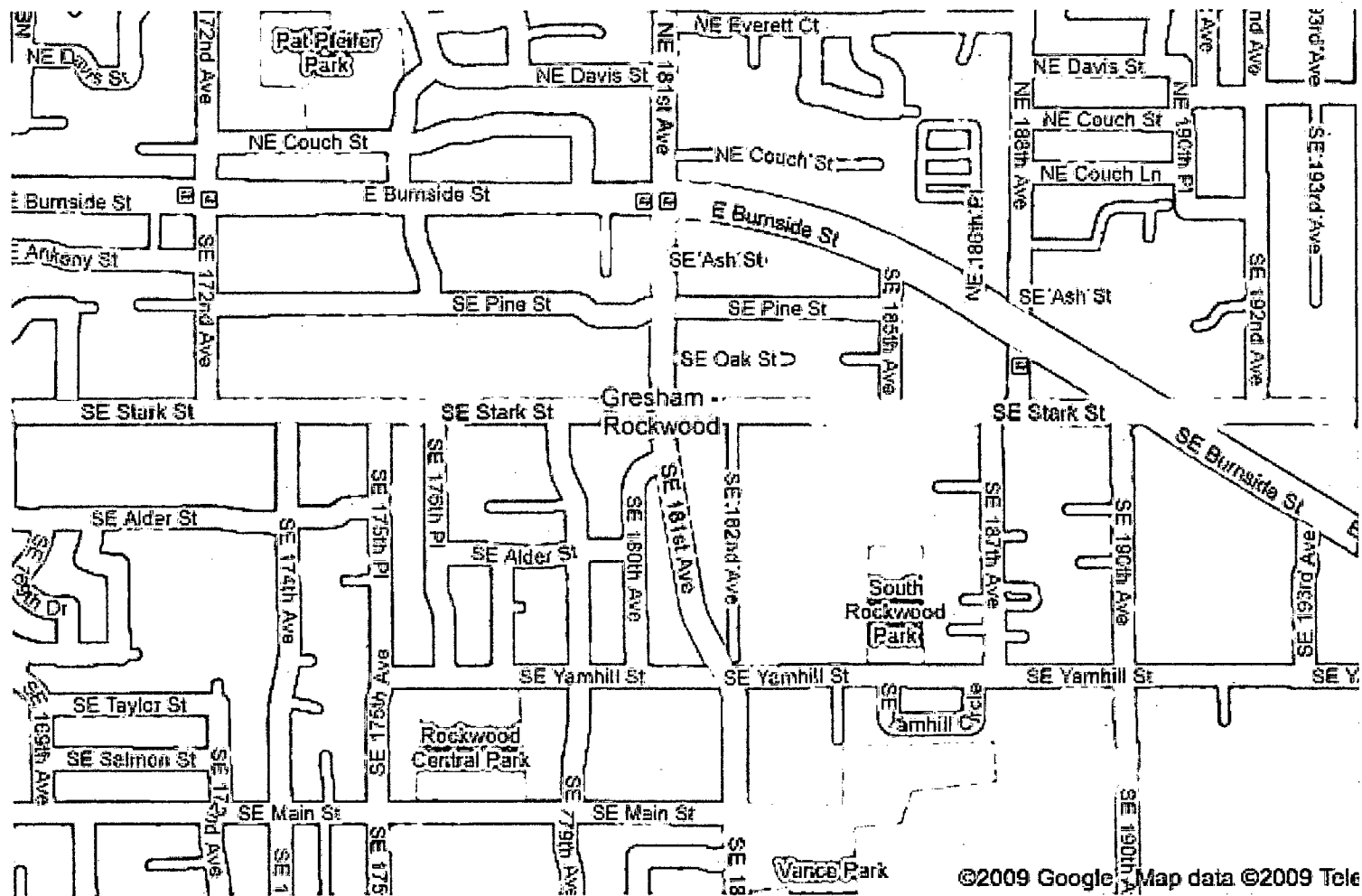

What's available?

- **US Department of Energy through Clean Cities Program intends to grant \$300 million across 30 grants**
- **Oregon would like to submit one application in partnership across the state.**
- **The grant requires a 50% match. If Oregon applies for \$10 million then that amount is required for match**
- **Funds can be used to help grantees acquire hybrid, battery-powered, all-electric vehicles and charging infrastructure**



What the State wants to achieve...

- **Increase the number of EVs in Oregon**
- **Deploy EV infrastructure in a manner that is consistent with the way the market develops**
- **Conduct public outreach, education and training about EVs**
- **Advance and promote green technology in the private sector**
- **Reduce greenhouse gas emissions**



Multnomah County's steps

- **Work with both the State and City of Portland on the application**
- **The State is coordinating a soft offer from partners as its first step in the application process. This is due April 10th.**
- **Motor pool replacement funds offer the best opportunity for the County match for vehicles**
- **Replacement should target electric vehicles as the grant is structured to pay for the entire incremental cost difference**



Challenges

- **Identifying matching funds for charging stations.**
- **Estimates for a station and install range up to \$5,000 for indoor and up to \$18,000 for outdoor stations**
- **Ongoing replacement of more expensive EVs**



Benefits

- **Reduces the County's fuel use**
- **Reduces County's exposure to gas and diesel price spikes and cost increases**
- **Reduction of County output of benzene and particulates**
- **Noise reduction**
- **Increases staff familiarity with green technology**
