1. What action are you requesting from the Board?

Acting as the Multnomah County Library District (MCLD) Board, request Board approval of appointment of Marc Alifanz to the Multnomah County Library Advisory Board. Mr. Alifanz's term will run from July 1, 2012 through June 30, 2016.

Request Board approval of appointment of Elizabeth Hawthorne to the Multnomah County Library Advisory Board. Ms. Hawthorne's term will run from July 1, 2014 through June 30, 2018.

Request Board approval of appointment of Jack MacNichol to the Multnomah County Library Advisory Board. Mr. MacNichol's term will run from July 1, 2013 through June 30, 2017.

Request Board approval of appointment of Brian Wilson to the Multnomah County Library Advisory Board. Mr. Wilson's term will run from July 1, 2014 through June 30, 2018.

Nominees for the Library Advisory Board are advanced to the MCLD Board after being

approved for recommendation by current board members. There are 17 members, including two youth members (between the ages of 13-17). Once appointed to the LAB by the MCLD Board, non-youth members are appointed to four-year terms. These candidates have met the criteria for membership on the board, including interviews with current board members.

Mr. Alifanz, Ms. Hawthorne, Mr. MacNichol and Mr. Wilson have indicated their willingness to be appointed and the Library Advisory Board has voted to recommend their appointments.
