
On June 4, 2010, we sent you a certified letter containing a check from PCRI's insurer in the amount of \$4,775, in full satisfaction of Judge Jones's Order Setting Damages, and as reiterated in his Order on PCRI's Motion for Summary Judgment. On July 27, 2010, we received that letter back as unclaimed. That letter, like this one, was sent to you at the following address: P.O. Box 11008, Portland, OR 97211, which is the address we have on file for you. We verified with the Post Office this morning that that P.O. Box is presently active.

On July 27, 2010, we sent you an email asking if there was a different address where you would like us to send the check. Having received no response to that letter, we resent the check to you in a letter dated August 17, 2010. PCRI's insurer has advised that the check, which has now been sent to you twice, has never been cashed. As the check, dated May 15, 2010, expires after 180 days, PCRI's insurer stopped payment on that check and has sent us the enclosed new check in the amount of \$4,775. The insurance company will not reissue payment in this matter should you choose to not cash this check.
