ORDINANCE READ BY TITLE ONLY. COPIES AVAILABLE. COMMISSIONER CRUZ MOVED AND COMMISSIONER LINN SECONDED, APPROVAL OF SECOND READING AND ADOPTION. COMMISSIONER CRUZ EXPLANATION. PORTLAND STATE UNIVERSITY STUDENT MICA DEVIN TESTIMONY IN SUPPORT. ORDINANCE 955 UNANIMOUSLY APPROVED.

COMMISSIONER CRUZ MOVED AND COMMISSIONER NAITO SECONDED, APPROVAL OF R-5. COMMISSIONER CRUZ EXPLANATION AND COMMENTS IN SUPPORT. JAIME BALBOA OF BASIC RIGHTS OREGON, AMALIA ALARCON GADDIE OF METROPOLITAN HUMAN RIGHTS CENTER, KRISTINE BURR OF OREGON GAY AND LESBIAN LAW, DONALD ROSS OF PARENTS AND FAMILIES OF LESBIANS AND GAYS, SVEN BONNICHSEN OF PORTLAND BI-SEXUAL ALLIANCE, AND ROY COLE, SENIOR PASTOR OF METROPOLITAN COMMUNITY CHURCH TESTIMONY IN SUPPORT. BOARD COMMENTS IN SUPPORT. CHAIR STEIN THANKED COMMISSIONERS NAITO AND CRUZ FOR BRINGING THIS ISSUE FORWARD. RESOLUTION 00-205 UNANIMOUSLY APPROVED.

### **R-6 DE NOVO HEARING, TESTIMONY LIMITED TO 20 MINUTES PER SIDE Regarding the Appeal of the Hearings Officer Decision on SEC 0-5, an Appeal of an Administrative Decision Approving an SEC Permit to Allow Placement of a Sport Court and Weight Room in the SEC Wildlife Habitat Overlay Zone on Property Located at 13939 NW GERMANTOWN ROAD, PORTLAND**

CHAIR STEIN EXPLAINED QUASI-JUDICIAL PROCESS. AT CHAIR STEIN'S REQUEST FOR DISCLOSURE, NO EX PARTE CONTACTS WERE REPORTED. AT CHAIR STEIN'S REQUEST FOR CHALLENGES AND/OR OBJECTIONS, NONE WERE OFFERED. COUNTY PLANNER VIRGINIA BOWERS PRESENTED STAFF REPORT AND RESPONSE TO QUESTION OF CHAIR STEIN ADVISING A DRAFT

MOTION HAS BEEN PROVIDED TO PARTIES. HEARINGS OFFICER JOAN CHAMBERS PRESENTED CONDITIONS, FINDINGS OF FACT AND CRITERIA USED IN DETERMINATION TO DENY APPEAL. OPPONENTS CLAIRE STOCK AND ARNOLD ROCHLIN TESTIMONY AGAINST APPROVING PERMIT TO ALLOW PLACEMENT OF A SPORT COURT AND WEIGHT ROOM IN THE SIGNIFICANT ENVIRONMENTAL CONCERN WILDLIFE HABITAT OVERLAY ZONE. ATTORNEY DANA KRAWCZUK REPRESENTING APPLICANTS DIANE JENKINS AND WILLIAM BABCOCK TESTIFIED THAT HER CLIENTS ARE DOING EVERYTHING THEY CAN TO REMEDY THE FACT THAT THEY BUILT A SPORT COURT AND WEIGHT ROOM WITHOUT A PERMIT AND TESTIFIED IN SUPPORT OF RESOLVING THE MATTER PRIOR TO THE LAND USE BOARD OF APPEAL'S JURISDICTIONAL ISSUE AND RESPONDED TO A QUESTION OF COMMISSIONER NAITO REGARDING "CUSTOMARILY ACCESSORY". ARNOLD ROCHLIN REBUTTAL AS TO WHAT DRIVEWAY HE WAS DISCUSSING; ADVISING FOREST PARK NEIGHBORHOOD ASSOCIATION FILED ON THEIR OWN WITH WAS NO FEE WAIVER; AND ADVISING THAT NEIGHBORS MR. AND MRS. WEISMANN ARE HERE TO RESPOND TO BOARD QUESTIONS. MR. ROCHLIN URGED THE BOARD TO GO BY THE RECORD AND NOT USE "CUSTOMARILY ACCESSORY" CRITERIA ON RURAL PROPERTY. COUNTY ATTORNEY SANDRA DUFFY RESPONSE TO A QUESTION OF COMMISSIONER NAITO. AT THE REQUEST OF CHAIR STEIN AND WITH NO REQUEST FOR CONTINUANCE OR OBJECTIONS TO THE HEARING, THE HEARING CLOSED. COMMISSIONER KELLEY'S MOTION TO AMEND THE HEARINGS OFFICER DECISION WAS SECONDED BY COMMISSIONER CRUZ FOR PURPOSES OF DISCUSSION. COMMISSIONER NAITO ADVISED SHE FINDS THE NEIGHBORS' TESTIMONY VERY RELEVANT AND OPPONENTS' ARGUMENT VERY COMPELLING. FOLLOWING DISCUSSION BETWEEN CHAIR STEIN AND MS. KRA WCZUK, COMMISSIONERS KELLEY AND CRUZ WITHDREW THEIR FORMER MOTION. AT THE REQUEST OF CHAIR STEIN AND UPON MOTION OF COMMISSIONER CRUZ, SECONDED BY COMMISSIONER NAITO, IT WAS APPROVED THAT TO CONTINUE THE DECISION TO 9:30 AM, THURSDAY, JANUARY 25, 2001, WITH COMMISSIONERS CRUZ, KELLEY, NAITO AND STEIN VOTING AYE.
