RESOLUTION NO. 06-197

Appointing the Chair and Members of the Permanent Work Group to Advise the County Commission on Jail Policies and Procedures for a Term of One Year, Commencing on December 1, 2006

The Multnomah County Board of Commissioners Finds:

- a. The District Attorney's *Independent Review of Policies and Procedures of Correctional Facilities Operated by the Multnomah County Sheriff's Office*, issued November 1, 2006, recommends, "The Board of County Commissioners should create a permanent jail oversight committee to assist the Board in its legal oversight functions."
- b. The Multnomah County Board of Commissioners has resolved today to establish a Permanent Work Group to advise the county commission on jail policies and procedures and to appoint the members of this committee.

The Multnomah County Board of Commissioners Resolves:


