**The Multnomah County Library District (MCLD) Board Finds:**

- a. The MCLD budget, as prepared by the duly appointed MCLD Director/Budget Officer, has been considered and approved by the MCLD Board.
- b. A public hearing on this budget was held before the Multnomah County Tax Supervising and Conservation Commission on the 5<sup>th</sup> day of June, 2013.
- c. The budget is now on file in the Multnomah County Library's Administrative Office.
