1. The Multnomah County Vector Control and Enforcement Advisory Committee will provide a community perspective and recommendations to vector planning and response. What interests or activities of yours may pertain to vectors and enforcement of codes that relate to community livability?

As the Ranger in charge of Government Island State Recreation Area, the necessity of mosquito control is very apparent. We manage a 17 mile long perimeter open to the public for recreation, and 2300 acres of interior where we perform invasive species control and habitat restoration. The serious impact on visitor enjoyment of a mosquito outbreak is very concerning to us. We also hear from our neighbors about their concerns. An outbreak also affects our ability to field work crews and volunteers and makes staff activities more difficult.

My 18 years in Parks have given me experience in providing and protecting natural, cultural, scenic and recreational resources to the visiting public, who come from around the world with sometimes competing interests and conduct. We in Parks always strive to balance these interests and conduct in the best interests of the public, the staff and the property.

Being a member of the Port of Portland Wildlife Advisory Committee and the Columbia Gorge Cooperative Weed Management Area, interagency interaction is quite familiar and useful. I am a member of the ORPD Invasive Species Committee, notably as editor of the Integrated Pest Management manual and Policy and Procedures and re-wrote the in house training module for pesticide application.

8. What perspectives or special skills do you feel you bring to the Advisory Committee?

My experience in outdoor recreation and invasive species management will bring both the Agency perspective of providing recreation opportunities and the requisite balancing of competing considerations in land use. This would be supported by my background in practical ecology. In invasive species management my perspectives are both Early Detection and Rapid Response and Integrated Pest Management.

9. What do you feel are the most important Environmental Health issues affecting Multnomah County?

In a populous urban area, the potential for disease transmission is highly important. A brief reflection on world history shows the inherent danger to human life and well-being of vector-borne illness. The natural environment carries the constant potential for new diseases or outbreaks of old enemies. As climate and populations change and adapt we will be continually challenged to prepare and respond.
