Becky & Sally,

I have some comments:

1. No one is identified as a presenter on the APR. This action is brought under ORS 275.110, and that statute requires it be done by BCC *Order*. Under County Administrative Procedure BCC-1, only Tax Title *Resolutions* are expressly allowed to go on the consent agenda. Best practice would be to have the matter on the regular agenda, not as a consent agenda item.
2. I added discussion in the APR about the IRS lien properties.
3. At some point over the last year, it was decided to give the Tax Assessor signing authority for earnest money and deeds in these Board Orders. Traditionally, this execution authority is vested in the Chair, but the Chair can delegate that authority. This traditional approach is more consistent with the County Charter that vests the administrative authority in the Chair. I modified the resolve clause to provide for signing authority to be vested in the Chair or the Chair's designee. We can work with the Program to implement a Chair Executive Rule to provide for the designation of the County Tax Assessor to sign the earnest money and deeds that are executed for these sheriff sales.
4. I modified the list with respect to properties nos. 15 and 16. See attached.

Jenny and I discussed these identified changes and find them appropriate. The attached Board Order has been reviewed and is approved for submission to the BCC for its consideration. The attached APR needs to be revised to identify a presenter, and is then ready for submission to the BCC.
