COMMISSIONER KELLEY MOVED AND COMMISSIONER LINN SECONDED, APPROVAL OF R-1. CATHY SPOFFORD EXPLANATION. NOTICE OF INTENT UNANIMOUSLY APPROVED, WITH COMMISSIONERS KELLEY, LINN, CRUZ AND STEIN VOTING AYE.

PRESENTATIONS BY GRESHAM MAYOR CHARLES BECKER, GRESHAM COMMUNITY REVITALIZATION PROGRAM PLANNER ANDREE TREMOULET, GRESHAM POLICY MANAGER RICHARD ROSS, AND MULTNOMAH COUNTY FACILITIES AND PROPERTY MANAGEMENT STAFF PATRICK JONES ON GRESHAM'S HOUSING AND COMMUNITY DEVELOPMENT STRATEGIES, INCLUDING THE COMMUNITY REVITALIZATION PROGRAM, RECENT PROJECTS, TRANSIT ORIENTED TAX EXEMPTION PROJECTS, LONG RANGE PLANNING. MAYOR BECKER AND RICHARD ROSS RESPONSE TO BOARD DISCUSSION REGARDING BOARD CONCERNS WITH GRESHAM'S CAP ON THE AMOUNT OF AFFORDABLE HOUSING THAT MAY BE INCLUDED IN A PROJECT APPLYING FOR TAX EXEMPT BENEFITS, THE AVAILABILITY OF AFFORDABLE HOUSING AND SPECIAL NEEDS HOUSING FOR ALL GRESHAM CITIZENS, AND GRESHAM'S BAN ON THE CONSTRUCTION OF RENTAL HOUSING IN WEST GRESHAM, INCLUDING THE ROCKWOOD NEIGHBORHOOD, WHICH LIMITS THE AVAILABILITY OF AFFORDABLE RENTAL HOUSING IN A HEAVY MINORITY AREA IN A MANNER THAT MAY BE DISCRIMINATORY; MAYOR BECKER TO NOTIFY BOARD OF UPCOMING COUNCIL WORKSHOPS LOOKING INTO ALTERNATIVES TO THE RENTAL BAN IN ORDER TO INSURE COMPLIANCE WITH FAIR HOUSING LAWS.

**R-3 Update on Status of Wapato Jail. Presented by Dan Noelle, Elyse Clawson, Bobbi Luna, Bob Nilsen and Ginger Martin.**

BOBBI LUNA AND BOB NILSEN PRESENTATIONS ON THE REVISED CONDITIONAL USE PERMIT APPLICATION FOR THE NORTH RIVERGATE SITE, THE WAPATO CORRECTIONS FACILITY CONSTRUCTION TIMELINES AND BUDGET STATUS. STAFF TO PROVIDE STANDARD REPORTING FORMAT AND ADD BACK THE BASELINE BUDGET INFORMATION FOR TRACKING AND COMPARISON PURPOSES. GINGER MARTIN PRESENTATION ON THE PILOT ALCOHOL AND DRUG TREATMENT PROGRAM PROJECT

UPDATE, INCLUDING TRANSITION PROCESS TO RESIDENTIAL TREATMENT AND LENGTH OF IN HOUSE TREATMENT. COMMISSIONER LINN REQUESTED STAFF TO CONTINUE GATHERING DATA TO DETERMINE APPROPRIATE LENGTH OF IN HOUSE TREATMENT. COMMISSIONER KELLEY REQUESTED A FUTURE BOARD BRIEFING ON THE INTERCHANGE PROGRAM, RELAPSE, AND OTHER POLICY ISSUES. IN RESPONSE TO QUESTIONS OF VICE-CHAIR CRUZ AND CHAIR STEIN, BOBBI LUNA AND BOB NILSEN ADDRESSED PERCENT FOR ART, FRIENDS OF SMITH AND BYBEE LAKES ENVIRONMENTAL MITIGATION, BOND, MARINE DRIVE IMPROVEMENTS, BUFFER AND WATER QUALITY ISSUES. IN RESPONSE TO QUESTIONS OF COMMISSIONER KELLEY, SHERIFF DAN NOELLE EXPLAINED THAT SINCE THE WAPATO FACILITY COMPLETION IS SCHEDULED FOR FALL, 2003, THEY HAVE DECIDED TO WAIT UNTIL NOVEMBER, 2002 TO PUT A LEVY FOR FACILITY OPERATING COSTS ON THE BALLOT, AND THAT THEY WILL BE IN A BETTER POSITION TO LOOK AT ALTERNATIVES IF THE LEVY FAILS AFTER THE NOVEMBER, 2000 ELECTION IN A FEW WEEKS.

ED BLACKBURN EXPLANATION OF THE EXTENSIVE COMMUNITY AND COORDINATING TEAM INPUT ON THE VARIOUS RESOLUTION DRAFTS, AND SUMMARY OF THE CONTENTS OF THIS LATEST VERSION, INCLUDING STATEMENTS REGARDING VALUES AND PRINCIPALS, REDEDICATION OF GOALS OF THE MENTAL HEALTH SYSTEM, NEED FOR CHANGES IN ATTITUDES, AND NEED TO REORGANIZE USING BEST PRACTICES AND MOST EFFICIENT USE OF RESOURCES. LADDIE READ, STEVE WEISS AND SCOTT SNEDECOR TESTIMONY IN SUPPORT OF THE COMMUNITY PROCESS AND IN SUPPORT OF BOARD ADOPTION OF THE SUBSTITUTE RESOLUTION. COMMISSIONERS NAITO, LINN, KELLEY, CRUZ AND STEIN COMMENTS REGARDING NEED FOR STATE AND FEDERAL PARTNERSHIP AND FUNDING FOR A REORGANIZED MENTAL HEALTH SYSTEM, COMMENTS SUPPORT OF THE SUBSTITUTE RESOLUTION, AND COMMENTS IN APPRECIATION OF THE EFFORTS AND DEDICATION OF ED BLACKBURN, RHYS SCHOLES AND THE 200 MULTNOMAH COUNTY CITIZENS ENGAGED IN THIS STEP IN THE PROCESS OF BRINGING THE MENTAL HEALTH INTO ALIGNMENT WITH OTHER SYSTEMS. RESOLUTION 00-161 ADOPTING A VISION STATEMENT FOR A CONSUMER AND FAMILY CENTERED MENTAL HEALTH SYSTEM UNANIMOUSLY APPROVED.
